On February 10, 2021, Colorado Interstate Gas Company, L.L.C. ("CIG") received a data request ("Data Request") from the Office of Energy Projects Regulation ("OEP") for information pertaining to CIG's proposed Flank Well Conversion Project. Accordingly, CIG is herein filing with the Federal Energy Regulatory Commission ("Commission") its response to the Data Request.

Description of Proceeding

On December 15, 2020, CIG filed a prior notice request pursuant to Sections 157.205, and 157.213(b) of the Commission's regulations under the Natural Gas Act for authorization to reclassify an injection/withdrawal well (Well No. 12), to an observation well at the Flank Natural Gas Storage Field located in Baca County, Colorado.

Description of Information Being Filed

CIG is herein submitting its responses to the Data Request.

1. Provide the average daily deliverability for Colorado Interstate Gas Company's Flank Storage Field's Well I/W #12 for the last three years the well was in use.

Response:

The average daily deliverability for Well I/W #12 for the last three years is as follows:

- 2018-2019 Season 0.26 MMcf per day
- 2019-2020 Season 0.30 MMcf per day
- 2020-2021 Season 0.48 MMcf per day

2. Provide CIG's total system-wide storage deliverability to confirm that abandonment of Well I/W #12, will have a de minimis impact to CIG's system-wide deliverability.

Response:

The CIG total system-wide storage deliverability that the Flank Storage field is associated with is 877 MMcf per day. Therefore, given the average daily deliverability for Well I/W #12 as presented in CIG's response to Data Request Number 1, CIG confirms that the reclassification of Well I/W #12 to an observation well will have a de minimis impact to CIG's system-wide deliverability.


