### Commissioners:

Colorado Interstate Gas Company, L.L.C. ("CIG") tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the enclosed informational filing showing penalties assessed by CIG for the 12-month period ending June 30, 2023.

## **Description of Filing**

Pursuant to General Terms and Conditions Section 14.2 of CIG's FERC Gas Tariff, Second Revised Volume No. 1, CIG files a report with the Commission on or before August 31 of each year detailing the cashout and scheduling imbalance penalties assessed for the twelve-month period ending the preceding June 30. Accordingly, the attached informational report provides, by shipper and by rate schedule, the penalties assessed by month for the twelve months ending June 30, 2023.

## **Procedural Matters**

Inasmuch as this filing is fully described in this transmittal letter, the statement of nature, the reasons and the basis for the instant tariff filing required by 18 C.F.R. § 154.7(a)(6) (2022) of the Commission's regulations is omitted.
