Colorado Interstate Gas Company, L.L.C. ("CIG") is hereby filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP19-56-000 its Weekly Environmental Inspector Report related to the CIG High Plains Kiowa Lateral Expansion Project.

Description of Proceeding

On January 24, 2019, CIG filed a prior notice request to Sections 157.205(b), 157.208(b), and 157.210 of the Commission's Regulations under the Natural Gas Act for authorization to construct and operate two laterals and metering facilities located in Weld County, Colorado. The project is referred to as the "CIG High Plains Kiowa Lateral Expansion Project".

In compliance with Section 157.208(c)(10) of the Natural Gas Act, CIG is providing Environmental Inspector Report No. 8 for the period of June 2, 2019 through June 8, 2019.

1. Summary of Construction Activity for Inspection Period:

During this report period, the hydrotest was completed at the Prairie Hound Meter Station. Welding continued at the High Five Meter Station and Kiowa Lateral.

2. Relevant Environmental Activities:

During this reporting period, ten (10) people received environmental training. A total of one-hundred and fifty-two (152) people have received training on the CIG High Plains Kiowa Lateral Expansion Project.

The set-up of the HDD drilling operations at County Road 49 was monitored. The installation of the environmental controls was monitored on the wetlands located at STA 73+37. The inspection team met with the contractor regarding placement of environmental controls to be used during the trenching of the wetlands located at STA 375+00. The wetland dewatering structures at STA 375+00 and the hydrostatic test at the Prairie Hound Meter Station were monitored. Water samples were taken prior to the start of the test and after the test for the hydrostatic test. The water was held in a frac tank pending sample results. The ROW is being watered as necessary to control dust.

One small inadvertent return was reported at the County Road 49 HDD location at approximately STA 455+78. Approximately 5 gallons of mud was identified, contained and cleaned. Drilling operations were shut down after the return was discovered to allow the area to seal up.

3. Environmental Problems/Issues and Corrective Actions Taken:

There were no environmental problems identified during this reporting period.

4. Environmental Compliance Issues/Resolutions:

There were no environmental compliance issues identified during this reporting period.

5. Issues and Concerns Identified by Landowners:

No landowner issues or concerns were identified during this reporting period.

6. Work Planned for the Following Reporting Period:



It is anticipated in the next reporting period that the construction contractor will dry the pipe and start bolting up piping at the Prairie Hound Meter Station. The construction contractor will continue welding and fabrication on the High Five Meter Station and pig traps. On the Kiowa Lateral the construction contractor will continue welding and start I-76 bore.


