Dear Ms. Reese:

Colorado Interstate Gas Company, L.L.C. ("CIG") is filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP25-7-000, an updated landowner and stakeholder list associated with the Powder River Abandonment Project pursuant to Section 157.6(d)(5) of the Commission's regulations, 18 C.F.R. § 157.6(d)(5) (2024).

Description of Proceeding

On October 17, 2024, CIG filed a prior notice request pursuant to Section 7(b) of the Natural Gas Act, 15 U.S.C. Section 717f(b) and Sections 157.7 and 157.18 of the Federal Energy Regulatory Commission's ("Commission") regulations, 18 C.F.R. Sections 157.7 and 157.18 (2024) for authorization to abandon, by sale, a portion of its Powder River Lateral system and abandon, in place, certain Powder River Lateral metering facilities. This project is referred to as the "Powder River Abandonment Project".

Description of Information Being Filed

CIG included the affected landowner list in Volume II, Exhibit Z-II of the certificate application, as privileged and confidential information, and mailed the notifications via certified mail to affected landowners required by Section 157.6(d)(i) of the Commission's regulations, 18 C.F.R. § 157.6(d)(i) (2024), within three business days of the issuance of the Commission's Notice of Application for the Projects on October 31, 2024.

As required by Section 157.6(d)(5), CIG is hereby submitting an updated list of affected landowner address information for the project. CIG notes that as of the date of this filing, forty-five (45) landowner notices have been mailed, five notices (5) are still pending delivery and are in the process of being tracked. If necessary, CIG will update the addresses for these five affected landowners. Additionally, one notification has

been returned as undeliverable and the mailing address is being researched. CIG will provide an updated landowner list once the addresses have been validated.

Filing Information

CIG is e-Filing this letter and response with the Commission's Secretary in accordance with the Commission's Order No. 703, *Filing Via the Internet*, guidelines issued on November 15, 2007 in Docket No. RM07-16-000.

Pursuant to 18 C.F.R. § 388.112, CIG is requesting privileged treatment of the attached updated landowner and stakeholder list. Accordingly, CIG has labeled this information "Contains CUI//PRIV – Do Not Release".
