# Re: Elba Express Company Compliance Filing Pursuant to Order 587-AA Docket No. RP25-

Dear Ms. Resse:

Pursuant to Section 4 of the Natural Gas Act ("NGA") and Section 154 of the regulations of the Federal Energy Regulatory Commission ("Commission" or "FERC") and the Commission's Order No. 587-AA in Docket No. RM96-1-043 ("Order No 587-AA"),<sup>1</sup> Elba Express Company ("EEC") hereby submits for filing with the Commission as part of its Eighth Revised Volume No. 1, the tariff record listed below proposed to be effective August 1, 2025.

Section 29 - NAESB Standards Version 9.0.0

As required by Order No. 587-AA, EEC requests an effective date of August, 1, 2025 for the proposed tariff record.

# Statement of Nature, Reasons and Basis for Filing

On November 22, 2024, the Commission issued a Final Rule in Docket No. RM96-1-043 to incorporate by reference into its regulations Version 4.0 of business practice standards as developed by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB"). The NAESB Version 4.0 package of standards contains revisions to enhance the cybersecurity-related standards that support the use of multi-factor authentication and new guidance encouraging the practice of whitelisting. This NAESB Version 4.0 also contains revisions to promote increased efficiencies in conducting commercial transactions as well as two new addendums to the NAESB Base Contract for the Sale and Purchase of Natural Gas that support transactions for certified gas and renewable natural gas. Each interstate natural gas pipeline is required to file a compliance filing reflecting the changed standards by February 3, 2025, to take effect on August 1, 2025.<sup>2</sup>

There are several Electronic Data Interchange ("EDI") related data set requirements that are not being used by EEC's customers for which EEC is requesting a continuation of an existing waiver or extension of time. These are data sets that are not being used by EEC's customers for which EEC is requesting a continuation of the existing waiver or extension of time. Order No. 587-AA maintained the process set forth in earlier orders for the continuation of such waiver requests. Specifically, Order No. 587-AA states:<sup>3</sup>

If the pipeline is requesting a continuation of an existing waiver or extension of time, it must include a table in its transmittal letter that identifies the standard for which the Commission granted a waiver or extension of time, and the docket number or order citation to the proceeding in which the Commission granted the waiver or extension of time. The pipeline also must present an explanation for why such waiver or extension of time should remain in force with regard to the WGQ Version 4.0 Standards.

Accordingly, the below table references the standard and the order citation for which the Commission granted the waiver or extension of time. As noted above, EEC has not received a request from any party to receive information via EDI pursuant to these data sets. Therefore, EEC respectfully requests a continuation of the extension of time for compliance until sixty days after EEC receives a request to comply with these listed EDI data set standards. This sixty day period will allow time for EEC to test and implement any of the listed EDI data sets.
