Dear Ms. Bose:

On September 22, 2023, EPNG submitted a Request for Prior Notice Authorization with the Federal Energy Regulatory Commission ("Commission") pursuant to its blanket certificate authorization in the above-referenced docket seeking authorization to construct, install, operate and maintain an approximately two-mile 30-inch outside diameter pipeline loop extension, located in Hudspeth County, Texas as part of its Line No. 1110 Loop Project. At the time of submission, EPNG inadvertently filed as public information certain privileged, non-public information. In order to correctly designate such information, EPNG is resubmitting various components of its filing with the corrected filing designations, all as explained below.

### **Description of Information Being Filing**

In the submitted file titled "EPNG Line No. 1110 Loop Project\_Part 4 of 8\_Vol I" under Accession Number 20230922-5110, EPNG provided certain archaeological site information as public information that should have been submitted as privileged. In order to limit the public access of such information, the Commission's filing office designated all of the associated files which included public information as privileged. In order to correct the security designation, EPNG is resubmitting the components of the September 22, 2023 filing under Accession Number 20230922-5110. Other than the updated security designation, EPNG affirms that the information provided is the same as originally filed.
