El Paso Natural Gas Company, L.L.C. ("EPNG") is hereby filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP26-156-000; its weekly construction status report related to EPNG's Permian West Expansion Project ("Project").

Description of Proceeding

On March 27, 2026, EPNG submitted a Request for Prior Notice Authorization Pursuant to Blanket Certificate in the above-referenced docket seeking authorization to construct, install, operate and maintain an approximately nine-mile, 30-inch outside diameter pipeline loop extension and related appurtenances, located in Hudspeth County, Texas as part of its Project.¹ The Project is designed to provide additional firm transportation capacity on EPNG's Line No. 1100 system.

Submittal of Status Report

In compliance with Section 157.208(c)(10) of the NGA, EPNG is providing its Environmental Inspector Report No. 2.

SUMMARY OF CONSTRUCTION ACTIVITY FOR INSPECTION PERIOD: During this reporting period, the contractor conducted the following activities: (1) continued to strip topsoil, mulch, clear, and grade the right-of-way ("ROW") and temporary workspace locations within the limits of disturbance; (2) installed erosion control devices along the ROW; and (3) prepared for pipe stringing activities by installing stringing skids along the ROW. 2. RELEVANT ENVIRONMENTAL ACTIVITIES: No new personnel were on site during this reporting period therefore, no applicable additional training was conducted. The environmental inspector conducted stormwater pollution prevention-related inspections and inspected all work areas each day for the presence of sensitive species. No sensitive species were observed. 3. ENVIRONMENTAL PROBLEMS/ISSUES AND CORRECTIVE ACTIONS TAKEN: No environmental problems or issues occurred during this reporting period. 4. ENVIRONMENTAL COMPLIANCE ISSUES/RESOLUTIONS: No environmental compliance issues or resolutions occurred during this reporting period. 5. ISSUES AND CONCERNS IDENTIFIED BY LANDOWNERS: No landowner issues or concerns were identified during this reporting period. 6.
