Commissioners:

On November 26, 2025, El Paso Natural Company, L.L.C. ("EPNG") filed its "Annual Recomputation of Fuel and Lost and Unaccounted for Retention Percentages, and EPC Charges with the Operational Purchases and Sales Report" in the above referenced docket ("November Filing"). Unfortunately, EPNG very recently discovered that a summary table on page 5 of the transmittal letter of the November Filing contained four incorrect percentages due to an administrative oversight. Accordingly, EPNG is submitting an updated table below with the corrected percentages.¹ To be clear, the proposed tariff records as well as the Appendices included with the November Filing were correct as submitted and the only changes to the original transmittal letter are the corrected percentages in the summary table below.
