# Commissioners:

El Paso Natural Gas Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed below for inclusion in its Third Revised Volume No. 1A FERC Gas Tariff ("Tariff"):

Part VII Section 77.1 ConocoPhillips #FT3EA000 Exhibit A Version 51.0.0 Part VII Section 77.2 ConocoPhillips #FT3EA000 Exhibit B Version 43.0.0

Proposed with an effective date of December 1, 2022, these tariff records update EPNG's Tariff to implement four separate temporary point redesignation requests on an existing transportation service agreement ("TSA") between EPNG and ConocoPhillips Company ("Conoco"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the December 1, 2022 effective date, as discussed below.

#### **Background**

TSA No. FT3EA000-FT1EPNG ("Conoco TSA") is a non-conforming, negotiated rate TSA which is included in EPNG's Tariff.<sup>1</sup> Most recently, EPNG submitted tariff records reflecting certain Conoco primary point redesignations for the Commission's review in Docket No. RP23-91-000, which were accepted by the Commission on November 16, 2022.

#### Reason for Filing

Pursuant to General Terms and Conditions ("GT&C") Section 8.1(f)(iii) of EPNG's Tariff, firm shippers may request to temporarily or permanently redesignate primary point

rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.<sup>2</sup> An acceptance of a redesignation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, Conoco separately submitted the following four requests to temporarily redesignate certain receipt point capacity for the period beginning December 1, 2022 and continuing through December 31, 2022.<sup>3</sup>

- 1. Move capacity from the IZORRO receipt point to the IPEREGRI receipt point.
- 2. Move capacity from the IZORRO receipt point to the IANGELES receipt point.
- 3. Move capacity from the ISANDBND receipt point to the IANGELES receipt point.
- 4. Move capacity from the IRAMSEYS receipt point to the IORBISON receipt point.

EPNG notes that the IORBISON, IPEREGRI and IANGELES points are currently listed as alternate receipt locations at which the negotiated rate specified in the Conoco TSA applies.<sup>4</sup> Each of Conoco's four requests was separately evaluated and accepted by EPNG and, therefore, the Conoco TSA was deemed to be amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.<sup>5</sup> Given that Conoco's temporary redesignation requests affect a non-conforming, negotiated rate agreement, EPNG is submitting updated tariff records to reflect the receipt location modifications and the relevant time period. No other changes have been made to the Conoco TSA.

#### **Tariff Provisions**

EPNG is submitting the following tariff records pursuant to 18 C.F.R. § 154.112(b) (2021) and Subpart C of the Commission's regulations.<sup>6</sup>

See Section 8.1(f)(iii)(B) of the GT&C of EPNG's Tariff.

These temporary redesignations are similar to other receipt point redesignations applicable to the Conoco TSA which were filed by EPNG and accepted by the Commission in Docket Nos. RP22-1185-000, RP22-1281-000 and RP23-91-000. See, e.g., El Paso Natural Gas Co., Docket No. RP23-91-000 (Nov. 16, 2022) (unpublished letter order).

IORBISON (PIN 53972), IPEREGRI (PIN 54856) and IANGELES (PIN 50506) are included within the group of STML PER (PIN 302346) listed in Exhibit B of the Conoco TSA at which the negotiated rate applies.

See Appendix A for copies of the redesignation reports for Agreement No. FT3EA000-FT1EPNG. These reports reflect the details regarding Conoco's redesignation requests and EPNG's approval of such requests.

<u>Part VII, Sections 77.1 and 77.2</u> are updated to reflect the requested capacity redesignations effective December 1, 2022 for the Conoco TSA.

## **Procedural Matters**

In accordance with the applicable provisions of Part 154 of the Commission's regulations,<sup>7</sup> EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, copies of the redesignation reports for Agreement No. FT3EA000-FT1EPNG; and
- c) clean and marked versions of each tariff record in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective December 1, 2022, consistent with the effective date of the redesignation requests. As such, EPNG requests the Commission grant a waiver of the notice requirements found in 18 C.F.R. § 154.207 (2021) of the Commission's regulations.<sup>8</sup> With respect to any tariff records the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff records in to effect at the end of any minimal suspension period established by the Commission.


