Re: Negotiated Rate Agreement Update:

El Paso Natural Gas Company, L.L.C.; Docket No. RP24-

Commissioners:

El Paso Natural Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed below for inclusion in Part VII of its FERC Gas Tariff, Third Revised Volume No. 1A ("Tariff"):

Section 124.1 Arizona Electric Power #619229-FT1EPNG Exh A Version 2.0.0 Section 124.2 Arizona Electric Power #619229-FT1EPNG Exh B Version 2.0.0

Proposed with an effective date of October 1, 2024, these tariff records update EPNG's Tariff to reflect a temporary point redesignation on an existing transportation service agreement ("TSA") between EPNG and Arizona Electric Power Cooperative, Inc. ("AEPCO"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the October 1, 2024 effective date, as discussed below.

Background

EPNG's Tariff includes Agreement No. 619229-FT1EPNG, a non-conforming, negotiated rate agreement with AEPCO ("AEPCO TSA"). Among other things, this TSA reflects the application of a fixed negotiated reservation rate between the primary points. Following the initial acceptance of the tariff records reflecting the TSA, AEPCO redesignated one of its primary points consistent with

EPNG's Tariff. As a result, the tariff records reflecting the AEPCO TSA include a point redesignation that was accepted by the Commission on August 5, 2024.²

Reason for Filing

Pursuant to General Terms and Conditions ("GT&C") Section 8.1(f)(iii) of EPNG's Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.³ An acceptance of a redesignation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, AEPCO submitted a request to temporarily shift some of its capacity from the primary delivery point of IWILCOXD (PIN 302080) to DAEPCWIL (PIN 300754) on Agreement No. 619229-FT1EPNG for October 1, 2024 through October 31, 2024, as indicated on the attached tariff records. AEPCO's request was accepted by EPNG and, therefore, Agreement No. 619229-FT1EPNG was deemed to be amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.⁴ Given that AEPCO's temporary redesignation request affects a non-conforming, negotiated rate agreement, EPNG is proposing to update the relevant tariff records to reflect the delivery point modification and the relevant time period.⁵ No other changes to the TSA have been made.

Tariff Provisions

EPNG is submitting the following tariff record pursuant to 18 C.F.R. § 154.112(b) (2024) and Part 154, Subpart C of the Commission's regulations.⁶

Part VII, Sections 124.1 and 124.2 are updated to reflect the redesignation to the DAEPCWIL delivery point for October 1, 2024 through October 31, 2024 for AEPCO's Agreement No. 619229-FT1EPNG.

This temporary redesignation is similar to other point redesignations, which were filed by EPNG and accepted by the Commission in Docket Nos. RP24-350-000, RP24-874-000 and RP24-961-000. See, e.g., El Paso Natural Gas Co., Docket No. RP24-874-000 (July 25, 2024) (unpublished letter order).

Procedural Matters

In accordance with the applicable provisions of Part 154 of the Commission's regulations,⁷ EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, a copy of the redesignation report for Agreement No. 619229-FT1EPNG; and
- d) clean and marked versions of the tariff records in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective October 1, 2024, contemporaneous with the effective date of the point redesignation. As such, EPNG requests the Commission waive the notice requirements as permitted by 18 C.F.R. § 154.207 (2024) of the Commission's regulations. With respect to any tariff record the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff record into effect at the end of any minimal suspension period specified by the Commission.
