Re: Negotiated Rate Agreement Update;

El Paso Natural Gas Company, L.L.C.;

Commissioners:

El Paso Natural Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed below for inclusion in Part VII of its FERC Gas Tariff, Third Revised Volume No. 1A ("Tariff"):

Section 33.1 Southern California Gas #615178-FT1EPNG Exh A Version 36.0.0 Section 33.2 Southern California Gas #615178-FT1EPNG Exh B Version 34.0.0

Proposed with an effective date of November 1, 2025, these tariff records update EPNG's Tariff to reflect two temporary point redesignations on an existing transportation service agreement ("TSA") between EPNG and Southern California Gas Company ("SoCal"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the November 1, 2025 effective date, as discussed below.

Background

EPNG's Tariff includes Agreement No. 615178-FT1EPNG, a non-conforming, fixed negotiated rate agreement with SoCal. Among other things, this TSA reflects the application of a negotiated rate at various primary and alternate points. Since the initial acceptance of the tariff records reflecting the TSA, SoCal has redesignated primary points consistent with EPNG's Tariff. Currently, the tariff

records reflecting the subject TSA include a point redesignation that was accepted by the Commission on August 25, 2025.²

Reason for Filing

Pursuant to General Terms and Conditions ("GT&C") Section 8.1(f)(iii) of EPNG's Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.³ An acceptance of a redesignation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, SoCal submitted two separate requests to temporarily redesignate capacity rights from its primary receipt point of KEYSTONE (PIN 302132) to IRAMSEYS (PIN 800908) and ICOWBOYR (PIN 54431) on Agreement No. 615178-FT1EPNG during the period November 1, 2025 through December 31, 2025, as indicated on the attached tariff records.⁴ Currently, IRAMSEYS is listed as primary receipt point and ICOWBOYR is included as an alternate receipt point at which the negotiated rate specified in the TSA applies. SoCal's requests were accepted by EPNG and, therefore, Agreement No. 615178-FT1EPNG was amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.⁵ Given that SoCal's temporary redesignation requests affect a non-conforming, negotiated rate agreement, EPNG is proposing to update the relevant tariff records to reflect the receipt point modifications and the relevant time periods.⁶ No other changes to the TSA have been made.

SoCal's request to redesignate capacity rights from KEYSTONE to IRAMSEYS is applicable to November 1, 2025 through November 30, 2025. Further, SoCal's request to redesignate capacity rights from KEYSTONE to ICOWBOYR is applicable to November 1, 2025 through December 31, 2025.

See Appendix A for copies of the redesignation reports for Agreement No. 615178-FT1EPNG. These reports reflect the details regarding SoCal's redesignation requests and EPNG's approval of such requests.

These temporary redesignations are similar to other receipt point redesignations applicable to Agreement No. 615178-FT1EPNG, which were filed by EPNG and accepted by the Commission in Docket Nos. RP25-426-000, RP25-871-000 and RP25-1045-000. See, e.g., El Paso Natural Gas Co., Docket No. RP25-871-000 (May 21, 2025) (unpublished letter order).

Tariff Provisions

EPNG is submitting the following tariff records pursuant to 18 C.F.R. § 154.112(b) (2025) and Part 154, Subpart C of the Commission's regulations.⁷

<u>Part VII, Sections 33.1 and 33.2</u> are updated to reflect receipt point redesignations from KEYSTONE to IRAMSEYS and ICOWBOYR during the period November 1, 2025 through December 31, 2025 for SoCal's Agreement No. 615178-FT1EPNG.

Procedural Matters

In accordance with the applicable provisions of Part 154 of the Commission's regulations,⁸ EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, copies of the redesignation reports for Agreement No. 615178-FT1EPNG; and
- d) clean and marked versions of the tariff records in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective November 1, 2025, contemporaneous with the effective date of the point redesignations. As such, EPNG requests the Commission waive the notice requirements as permitted by 18 C.F.R. § 154.207 (2025) of the Commission's regulations. With respect to any tariff record the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff record into effect at the end of any minimal suspension period specified by the Commission.

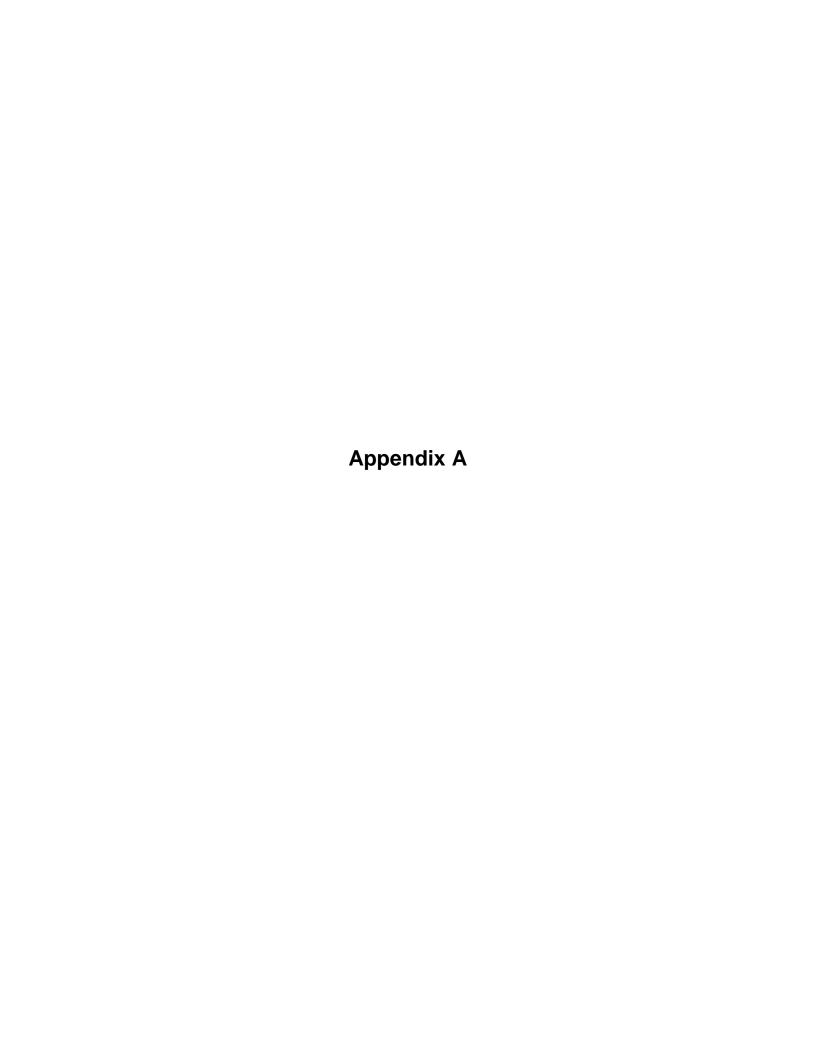

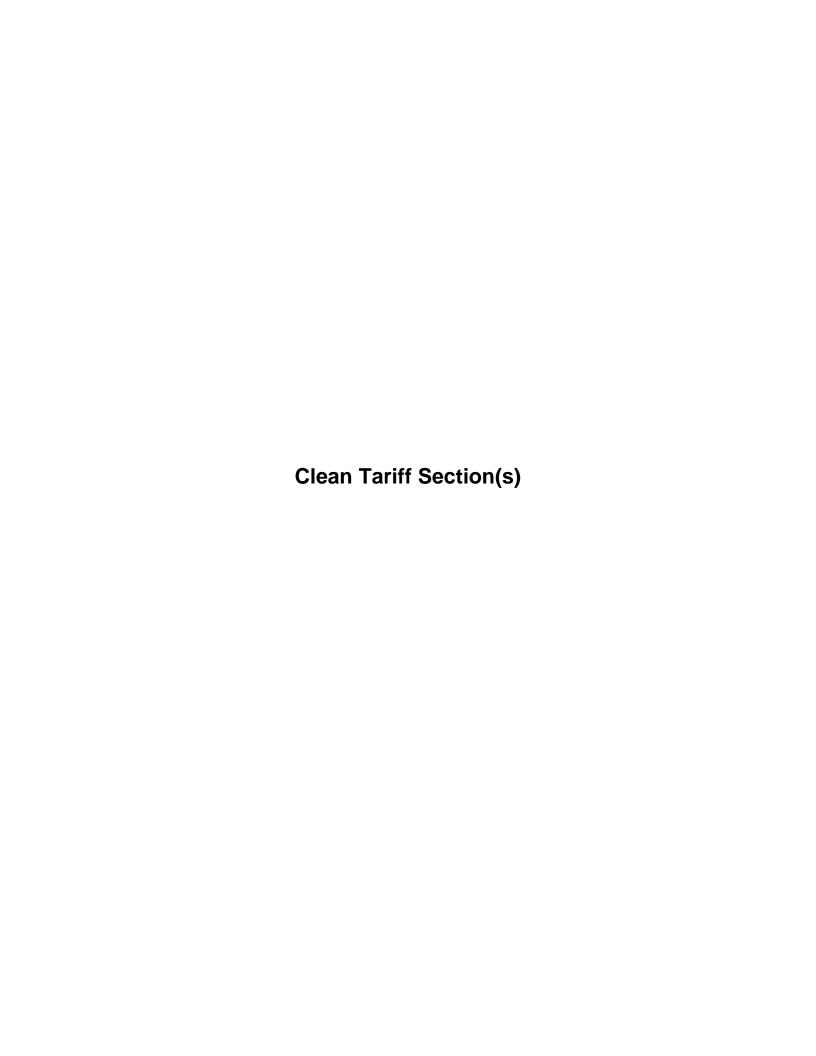
