El Paso Natural Gas Company, L.L.C.;

Commissioners:

El Paso Natural Gas Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff record listed below for inclusion in the Third Revised Volume No. 1A of its FERC Gas Tariff ("Tariff"):

Part II Section 5.13 EOG Resources, Inc. #610720-FT1EPNG Version 10.0.0

Proposed with an effective date of February 1, 2026, this tariff record updates EPNG's Tariff to reflect two temporary point redesignations on an existing transportation service agreement ("TSA") between EPNG and EOG Resources, Inc. ("EOG"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the proposed effective date, as discussed below.

Background

EPNG's Tariff includes Agreement No. 610720-FT1EPNG, a negotiated rate agreement with EOG ("EOG TSA"). Among other things, this TSA reflects the application of a fixed negotiated rate at various primary and alternate points. Currently, the tariff record reflecting the EOG TSA includes two point redesignations that were accepted by the Commission on November 14, 2025 in Docket No. RP26-154-000.¹

Reason for Filing

Pursuant to General Terms and Conditions (“GT&C”) Section 8.1(f)(iii) of EPNG’s Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.² An acceptance of a redesignation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, EOG submitted two separate requests to temporarily redesignate primary receipt point capacity rights for the period starting February 1, 2026 and ending April 30, 2026. The first request shifted capacity from the primary receipt point of IROCKDOV (PIN 48279) to the ITIGERRE (PIN 54859) receipt point for delivery to the DPG&ETOP (PIN 314604) primary delivery point. The second request shifted capacity from the primary receipt point of IROCKDOV (PIN 48279) to the ITIGERRE (PIN 54859) receipt point for delivery to the DSCALTOP (PIN 332503) primary delivery point. Because these redesignations are consistent with the prior temporary redesignations, no changes are shown for the primary receipt and delivery points in the redlined EOG TSA included with this filing. EPNG notes that the ITIGERRE receipt point is currently listed as an alternate receipt location at which the negotiated rate specified in the EOG TSA applies.³ The EOG requests were evaluated and accepted by EPNG and, therefore, the EOG TSA was amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.⁴ Given that EOG’s temporary redesignation requests affect a negotiated rate agreement, EPNG is submitting an updated tariff record to reflect the temporary modification of primary receipt rights.⁵ No other changes to the TSA have been made and the TSA conforms to the form of service agreement for Rate Schedule FT-1 contained in the Tariff.

Tariff Provisions

EPNG is submitting the following tariff record pursuant to 18 C.F.R. § 154.112(b) (2025) and Subpart C of the Commission’s regulations.⁶

Part II, Section 5.13 is updated to reflect the point redesignations for the relevant time period for the EOG TSA.

Procedural Matters

In accordance with the applicable provisions of Part 154 of the Commission's regulations,⁷ EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, copies of the redesignation reports for the EOG TSA; and
- c) clean and marked versions of the tariff record in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff record for filing and permit it to become effective February 1, 2026 consistent with the effective date of the point redesignations. As such, EPNG requests the Commission grant a waiver of the 30-day notice requirement as permitted by 18 C.F.R. § 154.207 (2025) of the Commission's regulations.⁸ With respect to any tariff record the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff record in to effect at the end of any minimal suspension period established by the Commission.
