Re: Negotiated Rate Agreements Update; El Paso Natural Gas Company, L.L.C.; Docket No. RP26-

Commissioners:

El Paso Natural Gas Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed in Appendix A for inclusion in its FERC Gas Tariff, Third Revised Volume No. 1A ("Tariff").

Proposed with an effective date of November 1, 2025, these tariff records update EPNG's Tariff to reflect temporary point redesignations on two existing transportation service agreements ("TSAs") between EPNG and Pioneer Natural Resources USA, Inc. ("Pioneer"). Additionally, EPNG is updating its Tariff to remove two negotiated rate TSAs as explained below. EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the proposed effective date, as discussed below.

Background

EPNG's Tariff includes Agreement Nos. FT3HH000-FT1EPNG and FT3JH000-FT1EPNG, both non-conforming, negotiated rate agreements with Pioneer ("Pioneer TSAs"). Among other things, these TSAs reflect the application of a fixed negotiated rate at various primary and alternate points for at least some time period. Since the initial acceptance of the tariff records reflecting the TSAs, Pioneer has redesignated primary points on each of these TSAs consistent with EPNG's Tariff. Currently, the tariff records reflecting the Pioneer TSAs include point redesignations that were accepted by the Commission on August 14, 2025 and October 22, 2025.²

Reason for Filing

Pursuant to Section 8.1(f)(iii) of the General Terms and Conditions ("GT&C") of EPNG's Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.³ An acceptance of a re-designation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, Pioneer submitted a redesignation request for Agreement No. FT3HJ000-FT1EPNG to temporarily shift some capacity from the primary receipt point of IMIDKIFF (PIN 314602) to ITLEGACY (PIN 55934) for November 1, 2025 through January 31, 2026. ITLEGACY is currently listed as a primary receipt point at which the negotiated rate specified in the TSA applies. Similarly, Pioneer submitted two requests to temporarily redesignate capacity rights from the primary receipt points of IUTBENED (PIN 377040) and IEDWRDPL (PIN 47817) to the IJOYCEPL receipt point (PIN 50532) on Agreement No. FT3HH000-FT1EPNG for November 1, 2025 through November 30, 2025, as indicated on the attached tariff record. Agreement No. FT3HH000-FT1EPNG is currently subject to the maximum tariff rate⁴ and, consequently, redesignation requests accepted for this TSA will be subject to the applicable maximum tariff rate as well. Pioneer's requests were accepted by EPNG and, therefore, the TSAs were deemed to be amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.5 Given that Pioneer's temporary redesignation requests affect non-conforming, negotiated rate agreements, EPNG is proposing tariff records to reflect the receipt point modifications and the relevant time periods. 6 No other changes to the Pioneer TSAs have been made.

Additionally, as noted earlier, EPNG is proposing to update its Tariff to remove two negotiated rate agreements, Agreement Nos. 617944-FT1EPNG and 620689-FT1EPNG. Agreement No. 617944-FT1EPNG, an agreement between EPNG and ETC Marketing, Ltd., will expire on October 31, 2025. Agreement No.

See Section 8.1(f)(iii)(B) of the GT&C of EPNG's Tariff.

The primary and alternate points specified in Agreement No. FT3HH000-FT1EPNG were subject to a negotiated reservation rate from January 1, 2017 through December 31, 2023. Beginning January 1, 2024 and continuing through the remaining term (i.e., through March 31, 2029), Pioneer's Agreement No. FT3HH000-FT1EPNG is subject to the applicable maximum reservation rate.

See Appendix A for copies of the redesignation reports for the Pioneer TSAs. These reports reflect the details regarding Pioneer's redesignation requests and EPNG's approval of such requests.

These temporary redesignations are similar to other receipt point redesignations, which were filed by EPNG and accepted by the Commission in Docket Nos. RP25-599-000, RP25-981-000 and RP25-1043-000. *See, e.g., El Paso Natural Gas Co.*, Docket No. RP25-981-000 (July 21, 2025) (unpublished letter order).

620689-FT1EPNG, an agreement between EPNG and Chevron U.S.A. Inc. ("Chevron"), was amended and extended effective July 1, 2025. As relevant here, the amended Chevron TSA is not subject to a negotiated rate during its term. Accordingly, these agreements should no longer be included in EPNG's Tariff as negotiated rate agreements.

Tariff Provisions

EPNG is submitting the following tariff records pursuant to 18 C.F.R. § 154.112(b) (2025) and Subpart C of Part 154 of the Commission's regulations.⁷

<u>Part VII, Section 95.1</u> is updated to reflect two point redesignations for the period of November 1, 2025 through November 30, 2025 for Pioneer's Agreement No. FT3HH000-FT1EPNG.

<u>Part VII, Section 96.1</u> is updated to reflect a point redesignation for November 1, 2025 through January 31, 2026 for Pioneer's Agreement No. FT3HJ000-FT1EPNG.

<u>Part II, Sections 5.37 and 5.46</u> reflect the removal of negotiated rate Agreement Nos. 620689-FT1EPNG and 617944-FT1EPNG for the reasons explained earlier. Accordingly, the index page for Negotiated Rate Agreements found on Part II, Section 5.0 is updated to remove these two TSAs.

Procedural Matters

In accordance with the applicable provisions of Part 154 of the Commission's regulations,⁸ EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, a list of the proposed tariff records;
- c) Appendix B, copies of the redesignation reports for the Pioneer TSAs; and
- d) clean and marked versions of the tariff records in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective November 1, 2025, contemporaneous with the effective date of the point redesignations for the Pioneer TSAs. As such, EPNG requests the Commission grant a waiver of the notice requirements as permitted by 18 C.F.R. § 154.207 (2025) of the Commission's regulations.⁹ With respect to any tariff record the Commission
