Enclosed for electronic filing is the annual report reflecting the Operational Purchases and Sales of Midcontinent Express Pipeline LLC (MEP) made pursuant to Section 10.6(c) of the General Terms and Conditions ("GT&C") of MEP's Gas Tariff for the twelve-month period ending December 31, 2022.

Section 10.6(c) of the GT&C of MEP's Gas Tariff requires MEP to file with the Federal Energy Regulatory Commission ("Commission") an annual report on operational purchases and sales of gas within 90 days of the end of each calendar year, indicating the source of the gas, date of the purchase/sale, volumes, purchase/sale price, costs and revenues from the purchase/sale, and the disposition of the costs and revenues. The attached Appendix A provides this information.
