NOTES:

- MEP transportation charges are calculated based on scheduled receipt quantity (Dth), whether it is a forward haul or a backhaul. Transportation to a pool is charged based on the pool zone. Transportation from a pool to points within the same zone is not subject to transportation charges. Transportation from a pool to another pool or delivery point in a different zone is charged based on the zone of the delivery.
- ACA surcharge is billed for each Dth received per day on a FTS or ITS agreement. ACA is revised annually to be effective October 1.
- MEP transportation fuel is filed semi-annually to be effective June 1 and December 1. Fuel is retained on transportation based on both the zone of receipt and on the zone of delivery. DART has a fuel calculator to determine the applicable fuel. To calculate fuel manually, for transportation across Zone 1 and Zone 2, the fuel rate is the sum of Zone 1 fuel gas plus Zone 2 fuel gas and System Haul Unaccounted for Gas. Fuel reimbursement applies on transportation to a Pool only. Transport away from a Pool to points within the same zone is not subject to fuel reimbursement. Transport to other zone, then fuel reimbursement for other zone only.
- EOIT transportation fuel is filed annually to be effective April 1. DART has a fuel calculator to determine the applicable fuel. To calculate fuel manually to determine the volume of receipts on the EOIT lease for delivery on MEP, first gross up the delivered volume for applicable MEP zone fuel. Then gross up that result for the applicable Lease fuel. The result is the receipt volume to be used at the EOIT Lease Pin.
- PIN 44598 Enable Delhi interconnect is deemed a zone 1 delivery and/ or a zone 2 receipt for rates and fuel calculations.
