Mojave Pipeline Company, L.L.C. ("Mojave") is hereby filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP21-495-000, its weekly status report related to the Oak Creek Delivery Point Project ("Project").

Description of Proceeding

On September 13, 2021, Mojave filed a prior notice request pursuant to Sections 157.203, 157.205, and 157.211 of the Commission's regulations under the Natural Gas Act for authorization to construct the Oak Creek Delivery Point located in Kern County, California. On September 23, 2021, the Commission issued a Notice of Request Under Blanket Authorization initiating the 60 day comment period to allow for any person or Commission's staff to file motions or notice to intervene and protests. Since no protests were filed within the comment period, the Project was deemed to be authorized on November 23, 2021.

Submittal of Status Report

Mojave is herein providing Environmental Inspector Report No. 3 for the period of October 16, 2022 through October 22, 2022.

Summary of Construction Activity for Inspection Period: Outside of potholing for Mojave and third-party gas and utility lines and installation of approximately 125-feet of safety fence around the potholes, there was no construction activity that occurred for Mojave's Oak Creek Delivery point during this reporting period. However, Michels Pipeline, Inc. ("Michels"), Mojave and CalPortland's construction contractor, began clearing for the CalPortland owned meter station site. Michels also delivered thirteen (13) joints of pipe to the CalPortland owned meter station site workspace.</p> <p>2. Relevant Environmental Activities: During this reporting period, one (1) person received environmental training.</p> <p>3. Environmental Problems/Issues and Corrective Actions Taken: There were no environmental problems or issues identified during this reporting period.</p> <p>4. Environmental Compliance Issues/Resolutions: There were no environmental compliance issues identified during this reporting period.</p> <p>5. Issues and Concerns Identified by Landowners: There were no landowner issues or concerns reported during this reporting period.</p> <p>6. Work Planned for the Following Reporting Period: Mojave does not anticipate any work to be done at its Oak Creek Delivery point site. However, during the next reporting period, Michels will begin stringing pipe at the CalPortland owned new meter station site.</p>
