The following terms and conditions shall apply to all requests for this capacity:

Fuel Gas and Gas Lost and Unaccounted For ("GLU"): Shipper shall pay Natural all applicable Fuel and Gas Lost and Unaccounted For charges set forth in Natural's FERC Gas tariff, as may be revised from time to time; provided, however, that the Fuel Gas component shall not be assessed to the extent that gas transported between any applicable Discounted Receipt Point(s) in Segment 10 and/or Segment 11 of the Mid-continent Receipt Zone (excluding the pool and storage points) and any applicable Discounted Delivery Point(s) represents a physical backhaul.

The following terms and conditions shall apply to any request for this capacity that represents a discount from Natural's applicable Maximum Tariff Reservation Rate:

<u>Discounted Secondary Receipt Points:</u> The requested rate shall apply to service provided on a firm basis from all secondary receipt points located in the Mid-continent Zone. Service provided on a firm basis from all other secondary receipt points not specifically set forth in this Section will be provided at the applicable maximum rate set forth in Natural's FERC Gas Tariff, as may be revised from time to time, for service to such points.

<u>Discounted Secondary Delivery Points</u>: The requested rate shall apply to service provided on a firm basis to all secondary delivery points located in the Permian Zone. Service provided on a firm basis to all other secondary delivery points not specifically set forth in this Section will be provided at the applicable maximum rate set forth in Natural's FERC Gas Tariff, as may be revised from time to time, for service to such points.

<u>Discounted Firm Transportation Quantity Limitation</u>: Shipper understands that the requested rate shall apply only to a total aggregate maximum daily firm transportation quantity equal to the Requested Contract MDQ (or such lesser amount as may be awarded to Shipper) for all quantities transported on a firm basis under the relevant transportation agreement and any associated capacity release replacement agreements. Any quantities transported on a firm basis in excess of the Discounted Firm Transportation Quantity Limitation shall be billed at all applicable maximum rates, charges, and surcharges set forth in Natural's FERC Gas Tariff, as may be revised from time to time.
