

Colorado Interstate Pipeline Maintenance Summary

This document lists major maintenance and construction outages that are being planned on the CIG pipeline system for the next 12 to 15 months. The purpose of this posting is to make customers aware of **proposed outages** that will affect throughput on the various systems of the pipeline. Dates may change based on changing business conditions or to coordinate with outages on interconnecting pipelines.
