On February 28, 2025, El Paso Natural Gas Company, L.L.C. (“EPNG”) submitted a Request for Prior Notice Authorization Pursuant to Blanket Certificate in the above-referenced docket seeking authorization to abandon, in place, the Monument Compressor Station Unit 1B, associated building and appurtenances located in Lea County, New Mexico as a part of its Monument Compressor Station Unit 1B Abandonment Project (“Project”).

EPNG submits this filing to supplement the prior notice application for the Project with the attached electronic hydraulic flow model files used to support the flow model exhibit provided with the prior notice application for the Project.

EPNG states that the hydraulic flow model files contain proprietary and competitively sensitive commercial, engineering or design information that is considered a trade secret and confidential information. In accordance with the Commission’s regulations, 18 C.F.R. § 388.112 (2025), EPNG hereby requests privileged treatment for this material and notes that the Commission routinely treats this type of information as privileged and exempt from mandatory disclosure under the Freedom of Information Act, 18 C.F.R. § 388.107(d) (2025); 5 U.S.C. § 552(b)(4). EPNG has labeled this material as “CUI//PRIV - Contains Privileged Information - Do Not Release.” The privileged material is also considered CEII pursuant to the Commission’s regulations 18 C.F.R. § 388.113 (2025), and has been labeled as “CUI//CEII - Contains Critical Energy Infrastructure Information - Do Not Release”.
