El Paso Natural Gas Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed below for inclusion in the Third Revised Volume No. 1A of its FERC Gas Tariff ("Tariff"):

Part VII Section 77.1 ConocoPhillips #FT3EA000-FT1EPNG Exh A Version 76.0.0

Proposed with effective dates of October 1, 2024 and October 2, 2024, these tariff records update EPNG's Tariff to reflect temporary point redesignations on an existing transportation service agreement ("TSA") between EPNG and ConocoPhillips Company ("Conoco"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the proposed effective dates, as discussed below.

Background

EPNG's Tariff includes Agreement No. FT3EA000-FT1EPNG, a non-conforming negotiated rate agreement with Conoco ("Conoco TSA"). Among other things, this TSA reflects the application of a fixed negotiated rate at various primary and alternate points. Currently, the tariff records reflecting the Conoco TSA include point redesignations that were accepted by the Commission on September 13, 2024 in Docket No. RP24-1003-000.

Reason for Filing

Pursuant to General Terms and Conditions (“GT&C”) Section 8.1(f)(iii) of EPNG’s Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.¹ An acceptance of a redesignation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, Conoco submitted five separate requests to temporarily redesignate capacity rights for primary receipt points as noted in the following table:

EPNG notes that the IPEREGRI, IANGELES and IORBISON receipt points are currently listed as alternate receipt locations at which the negotiated rate specified in the Conoco TSA applies.³ The Conoco requests were evaluated and accepted by EPNG and, therefore, the Conoco TSA was deemed to be amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.⁴ Given that Conoco’s temporary redesignation requests affect a non-conforming, negotiated rate agreement, EPNG is submitting updated tariff records to reflect the temporary modification of primary receipt rights.⁵ No other changes have been made to the Conoco TSA, including the previously accepted non-conforming provisions of the TSA.

Tariff Provisions

EPNG is submitting the following tariff records pursuant to 18 C.F.R. § 154.112(b) (2024) and Subpart C of the Commission's regulations.⁶

Part VII, Sections 77.1 and 77.2 is updated to reflect the point redesignations for the relevant time periods for the Conoco TSA.⁷

Procedural Matters

In accordance with the applicable provisions of Part 154 of the Commission's regulations,⁸ EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, copies of the redesignation reports for the Conoco TSA; and
- c) clean and marked versions of each tariff record in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective October 1, 2024 and October 2, 2024, consistent with the effective dates of the point redesignations. As such, EPNG requests the Commission grant a waiver of the 30-day notice requirement found in 18 C.F.R. § 154.207 (2024) of the Commission's regulations.⁹ With respect to any tariff records the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff records in to effect at the end of any minimal suspension period established by the Commission.
