Re: Negotiated Rate Agreements Update;  
El Paso Natural Gas Company, L.L.C.;

Commissioners:

El Paso Natural Gas Company, L.L.C. ("EPNG") hereby tenders for filing and acceptance by the Federal Energy Regulatory Commission ("Commission") the tariff records listed below for inclusion in its FERC Gas Tariff, Third Revised Volume No. 1A ("Tariff"):

Part VII Section 95.1 Pioneer Natural #FT3HH000-FT1EPNG Exh A Version 40.0.0  
Part VII Section 96.1 Pioneer Natural #FT3HJ000-FT1EPNG Exh A Version 22.0.0

Proposed with an effective date of July 1, 2024, these tariff records update EPNG's Tariff to reflect temporary point redesignations on two existing transportation service agreements ("TSAs") between EPNG and Pioneer Natural Resources USA, Inc. ("Pioneer"). EPNG respectfully requests a waiver of the 30-day notice requirement to effectuate the July 1, 2024 effective date, as discussed below.

## **Background**

EPNG's Tariff includes Agreement Nos. FT3HH000-FT1EPNG and FT3JH000-FT1EPNG, both non-conforming, negotiated rate agreements with Pioneer ("Pioneer TSAs"). Among other things, these TSAs reflect the application of a negotiated rate at various primary and alternate points. Since the initial acceptance of the tariff records reflecting the TSAs,<sup>1</sup> Pioneer has redesignated primary points on each of these TSAs consistent with EPNG's Tariff. Currently, the tariff records reflecting the Pioneer TSAs include point redesignations that were accepted by the Commission on June 13, 2024.<sup>2</sup>

### **Reason for Filing**

Pursuant to General Terms and Conditions (“GT&C”) Section 8.1(f)(iii) of EPNG’s Tariff, firm shippers may request to temporarily or permanently redesignate primary point rights to any rate zone subject to certain procedures. In the case of a temporary redesignation, a firm shipper may request to redesignate a primary point on its TSA for a period of three months or less and, in the same request, simultaneously redesignate back to the original primary point at the end of the redesignation period.<sup>3</sup> An acceptance of a re-designation request by EPNG constitutes an amendment of the TSA and an executed paper copy is unnecessary to amend the TSA as described in GT&C Section 8.1(f)(iii)(F).

Recently, Pioneer submitted a redesignation request for Agreement No. FT3HJ000-FT1EPNG to temporarily shift some capacity from the primary receipt point of IMIDKIFF (PIN 314602) to ITLEGACY (PIN 55934) for July 1, 2024 through September 30, 2024. ITLEGACY is currently listed as a primary receipt point at which the negotiated rate specified in the TSA applies. Similarly, Pioneer submitted two separate requests to temporarily shift capacity from the primary receipt points of IUTBENED (PIN 377040) and IEDWRDPL (PIN 47817) to IJOYCEPL (PIN 50532) on Agreement No. FT3HH000-FT1EPNG for July 1, 2024 through September 30, 2024, as indicated on the attached tariff record. Agreement No. FT3HH000-FT1EPNG is currently subject to the maximum tariff rate<sup>4</sup> and, consequently, redesignation requests accepted for this TSA will be subject to the applicable maximum tariff rate as well. Pioneer’s requests were accepted by EPNG and, therefore, Agreement Nos. FT3HH000-FT1EPNG and FT3HJ000-FT1EPNG were deemed to be amended pursuant to Section 8.1(f)(iii)(F) of the GT&C.<sup>5</sup> Given that Pioneer’s temporary redesignation requests affect non-conforming, negotiated rate agreements, EPNG is proposing tariff records to reflect the receipt point modifications and the relevant time periods.<sup>6</sup> No other changes to the Pioneer TSAs have been made.

## **Tariff Provisions**

EPNG is submitting the following tariff records pursuant to 18 C.F.R. § 154.112(b) (2023) and Subpart C of Part 154 of the Commission's regulations.<sup>7</sup>

Part VII, Section 95.1 is updated to reflect two redesignations to the IJOYCEPL receipt point applicable to July 1, 2024 through September 30, 2024 for Pioneer's Agreement No. FT3HH000-FT1EPNG.

Part VII, Section 96.1 is updated to reflect a redesignation to the ITLEGACY receipt point for July 1, 2024 through September 30, 2024 for Pioneer's Agreement No. FT3HJ000-FT1EPNG.

## **Procedural Matters**

In accordance with the applicable provisions of Part 154 of the Commission's regulations,<sup>8</sup> EPNG is submitting an eTariff XML filing package, which includes the following:

- a) a transmittal letter;
- b) Appendix A, copies of the redesignation reports for the Pioneer TSAs; and
- c) clean and marked versions of the tariff records in PDF format.

EPNG respectfully requests the Commission accept the tendered tariff records for filing and permit them to become effective July 1, 2024. As such, EPNG requests the Commission grant a waiver of the notice requirements as permitted by 18 C.F.R. § 154.207 (2023) of the Commission's regulations.<sup>9</sup> With respect to any tariff record the Commission allows to go into effect without change, EPNG hereby moves to place the tendered tariff record in to effect at the end of any minimal suspension period established by the Commission.
