T1	Cashout-T1	Cash out - Tier 1 - For any TSA with an end- of- month imbalance up to and including 2%
T2	Cashout-T2	Cash out - Tier 2 - For any TSA with an end-of-month imbalance greater than 2%, but less than or equal to 5%
Т3	Cashout-T3	Cash out - Tier 3 - For any TSA with an end-of-month imbalance greater than 5%, but less than or equal to 10%
