The following terms and conditions shall apply to any request for this capacity that represents a discount from Natural's applicable maximum tariff reservation rate:

<u>Discounted Secondary Receipt Points:</u> The requested rate shall apply to service provided on a firm basis from all secondary receipt points located in the zones traversed by the Primary Path including pooling and storage points in those zones. Service provided on a firm basis from all other secondary receipt points not specifically set forth in this Section will be provided at the applicable maximum rate set forth in Natural's FERC Gas Tariff, as may be revised from time to time, for service to such points.

<u>Discounted Secondary Delivery Points:</u> The requested rate shall apply to service provided on a firm basis to all pooling and storage points within the zones traversed by the Primary Path, as well as to the following Market Delivery Zone points: Nicor (Pin 9258), Nipsco (LOC 909260), MidAmerican (LOC 10568), PGL&C (LOC 909285), Northern Natural (LOC 900203), Northern Border (LOC 908090 & 50706), Alliance (LOC 37207 & 37208), ANR (LOC 906104 & 904758), Midwestern (LOC 906107 & 25400), Guardian Pipeline (LOC 40400), Panhandle (LOC 906103), and Rex (LOC 44413). Service provided on a firm basis to all other secondary delivery points not specifically set forth in this Section will be provided at the applicable maximum rate set forth in Natural's FERC Gas Tariff, as may be revised from time to time, for service to such points.

<u>Discounted Firm Transportation Quantity Limitation:</u> Shipper understands that the requested rate shall apply only to a total aggregate maximum daily firm transportation quantity equal to the Requested Contract MDQ (or such lesser amount as may be awarded to Shipper) for all quantities transported on a firm basis under the relevant transportation agreement and any

associated capacity release replacement agreements. Any quantities transported on a firm basis in excess of the Discounted Firm Transportation Quantity Limitation shall be billed at all applicable maximum rates, charges, and surcharges set forth in Natural's FERC Gas Tariff, as may be revised from time to time.
