Pursuant to Section 4 of the Natural Gas Act (“NGA”) and Part 154 of the regulations of the Federal Energy Regulatory Commission (“Commission” or “FERC”), Southern LNG Company, L.L.C. (“SLNG”) hereby submits for filing with the Commission as part of its FERC Gas Tariff (“Tariff”), the tariff record listed in Appendix A proposed to be effective August 1, 2019.

### **Background**

On November 15, 2018, the Commission issued a Final Rule in Docket No. RM96-1-041 to incorporate by reference into its regulations Version 3.1 of business practice standards as developed by the Wholesale Gas Quadrant (WGQ) of the North American Energy Standards Board (“NAESB”).<sup>1</sup> Order No. 587-Y includes modifications to the standards to clarify the processing of certain business transactions.

NAESB adopted two substantive revisions to its Nominations Related Standards as follows: (1) it established a standard rounding process for elapsed-prorated-scheduled quantity calculations; and (2) it revised the specifications for the information to be included in a nomination request.

NAESB also adopted three minor revisions to the WGQ Electronic Delivery Mechanism (EDM) Related Standards as follows: (1) it increased the allowable field length in ASCII Comma separated Value Files to 3000 characters; (2) it adopted new Standard 4.3.106 to allow checkboxes and radio buttons in the Transmission Service Providers’ (TSP) Electronic Bulletin Boards (EBB); and (3) it modified its standards to update the operating systems and web browsers that entities should support on behalf of users. Additionally, NAESB added clarifying language to the Secure Sockets Layer (SSL)/Transport Layer Security (TLS) protocols.

Other changes adopted by NAESB included changes to the NAESB WGQ data sets and other technical implementation documentation as well as revisions to the Flowing Gas Related datasets and technical implementation. In addition, NAESB revised the Imbalance Trade data set and revised two Sender's Option data elements. NAESB also adopted revisions to the Capacity Release Related data sets and technical implementation and revised Standard 6.3.1 (i.e., the NAESB Base Contract for Sale and Purchase of Natural Gas) to add language directing users to NAESB's copyright disclaimer posted on the NAESB website. Identical language was added to three additional NAESB WGQ Contracts. Lastly, NAESB adopted modifications to add a self-identification provision that assists end users in determining whether counterparties are commercial market participants as defined by the United States Commodity Futures Trading Commission.<sup>2</sup>

Each interstate natural gas pipeline is required to file a compliance filing reflecting the changed standards by April 1, 2019, to take effect on August 1, 2019.<sup>3</sup>

### **Statement of Nature, Reasons and Basis**

SLNG is hereby filing the revised tariff record in compliance with the Commission's November 15, 2018 Order No. 587-Y. Specifically, SLNG is revising Section 22 of its General Terms and Conditions ("GT&C") of its Tariff as follows: (1) to incorporate the two NAESB Standards adopted by reference in Order No. 587-Y; (2) to reflect NAESB WGQ Version 3.1 instead of version 3.0; (3) to remove the reference to Minor Corrections marked with an asterisk [\*] which are now included in Version 3.1; and (4) to update the NAESB Copyright year.

### **Effective Date**

SLNG respectfully requests that the Commission accept the tendered tariff record effective August 1, 2019, in accordance with the implementation date established by the Commission under Order No. 587-Y.
