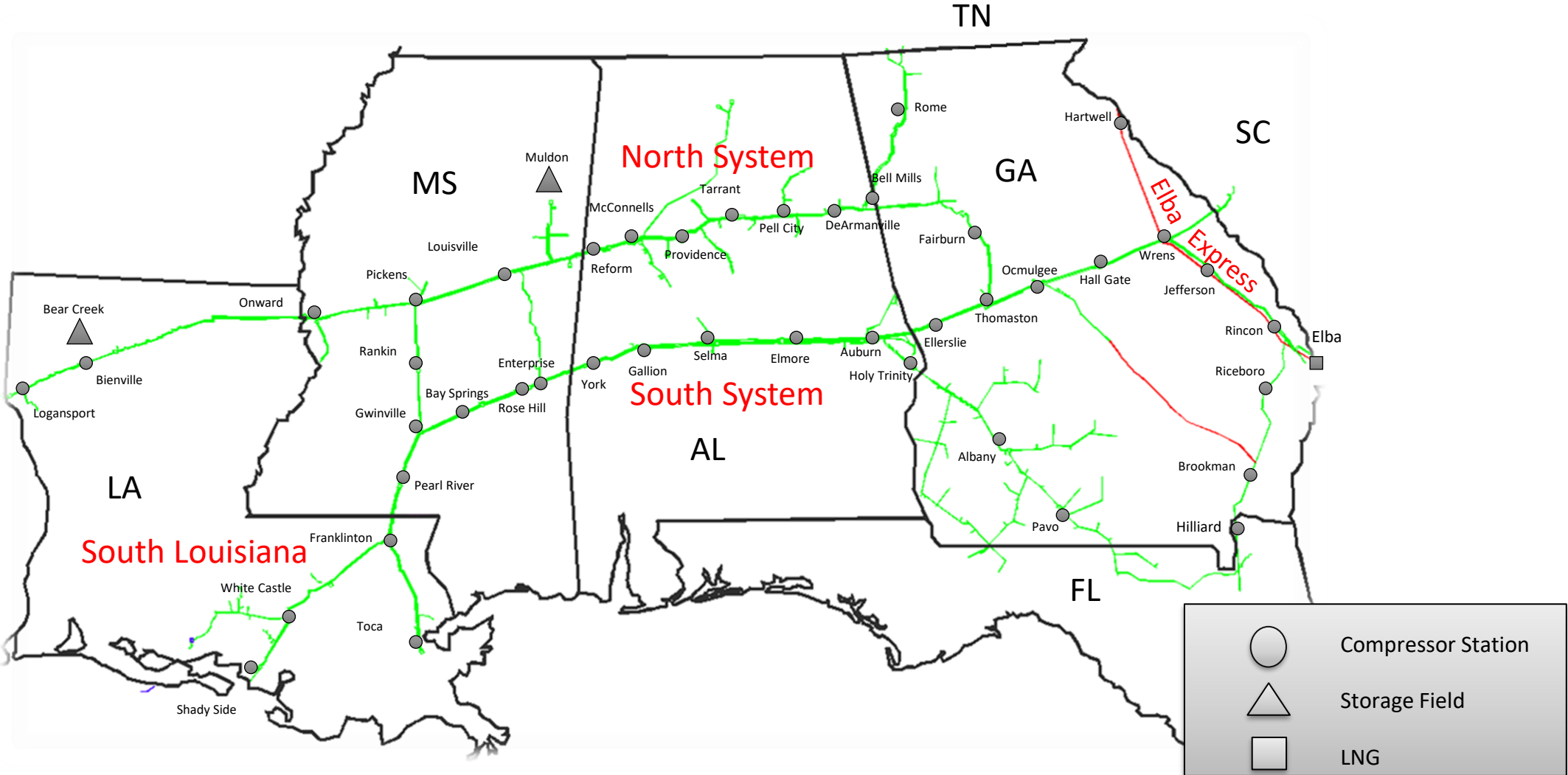
Disclaimers

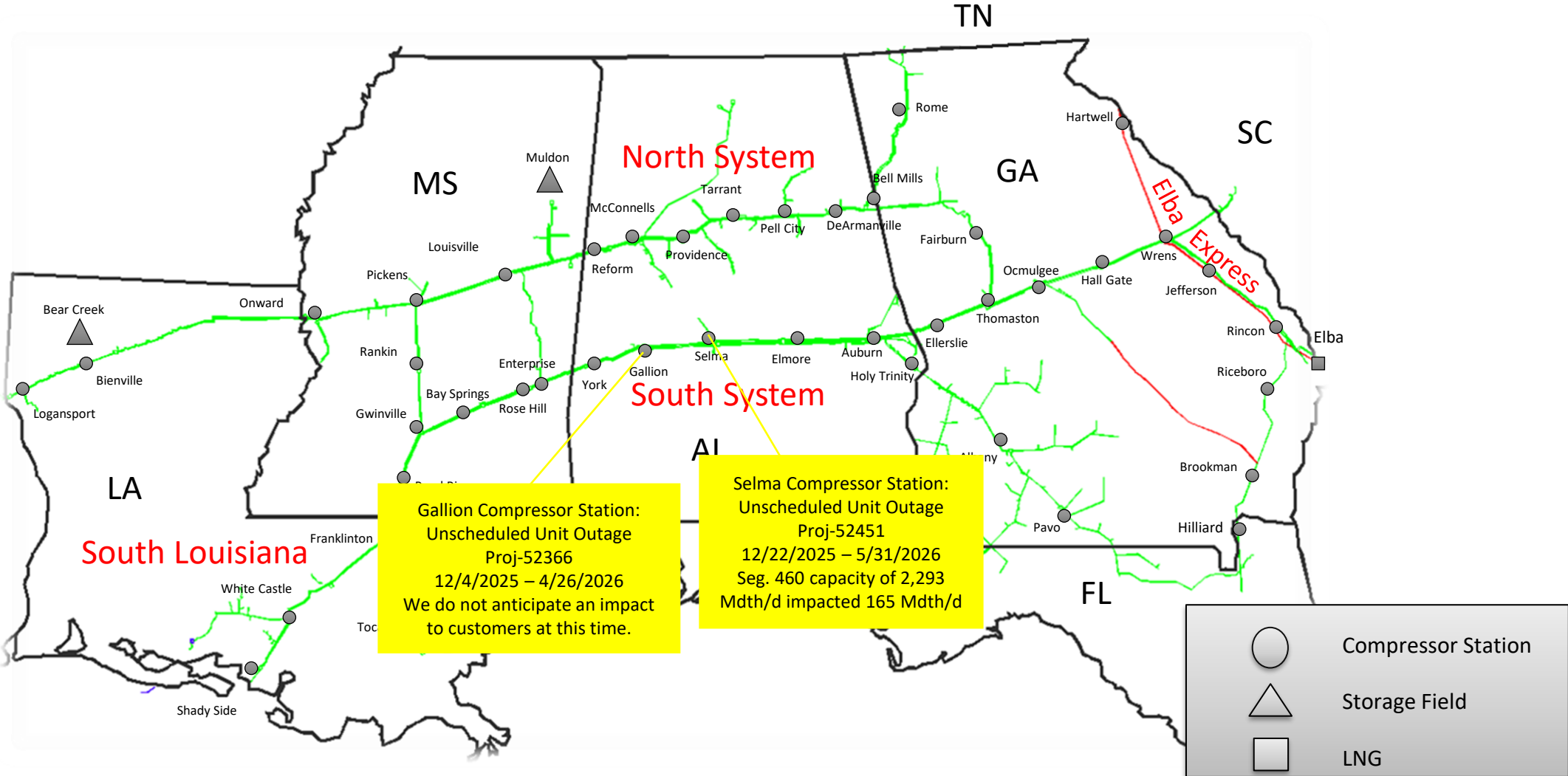


Southern Natural Gas Pipeline

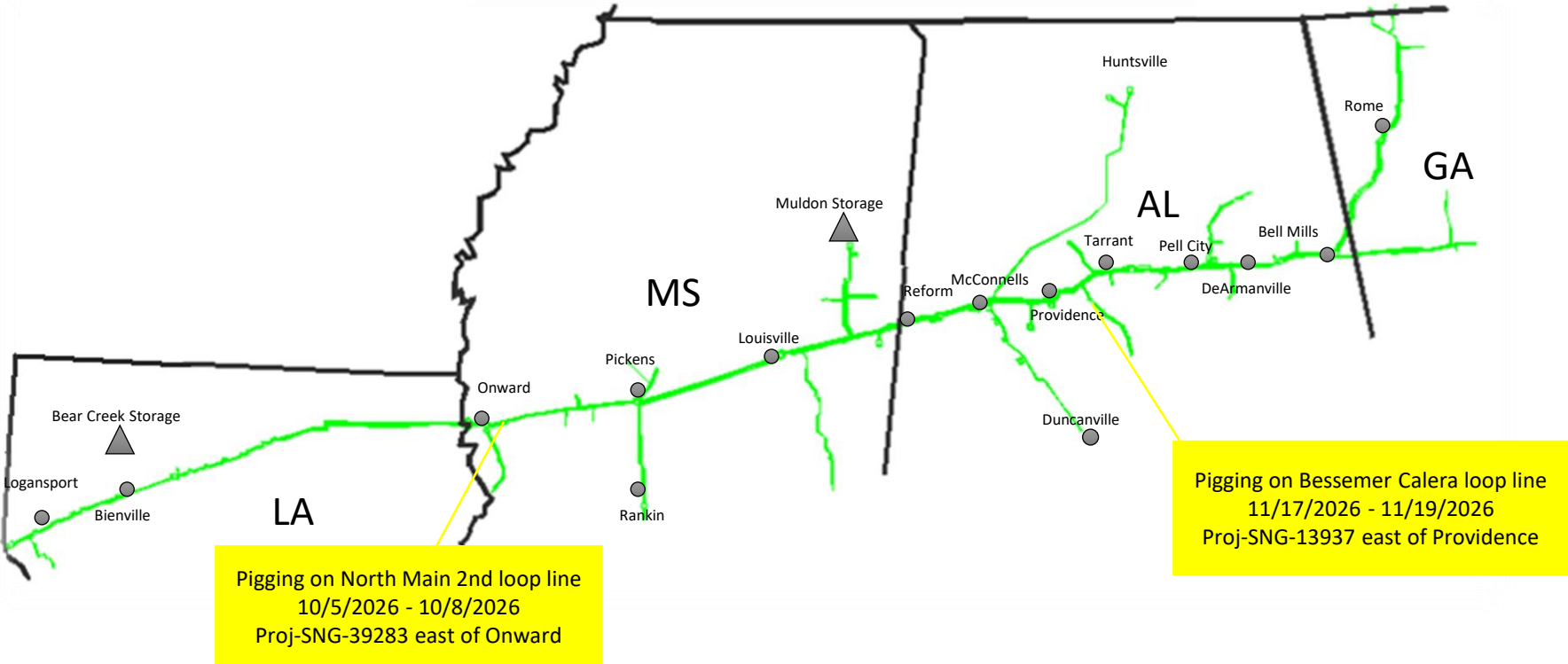


SNG North System Pigging Review

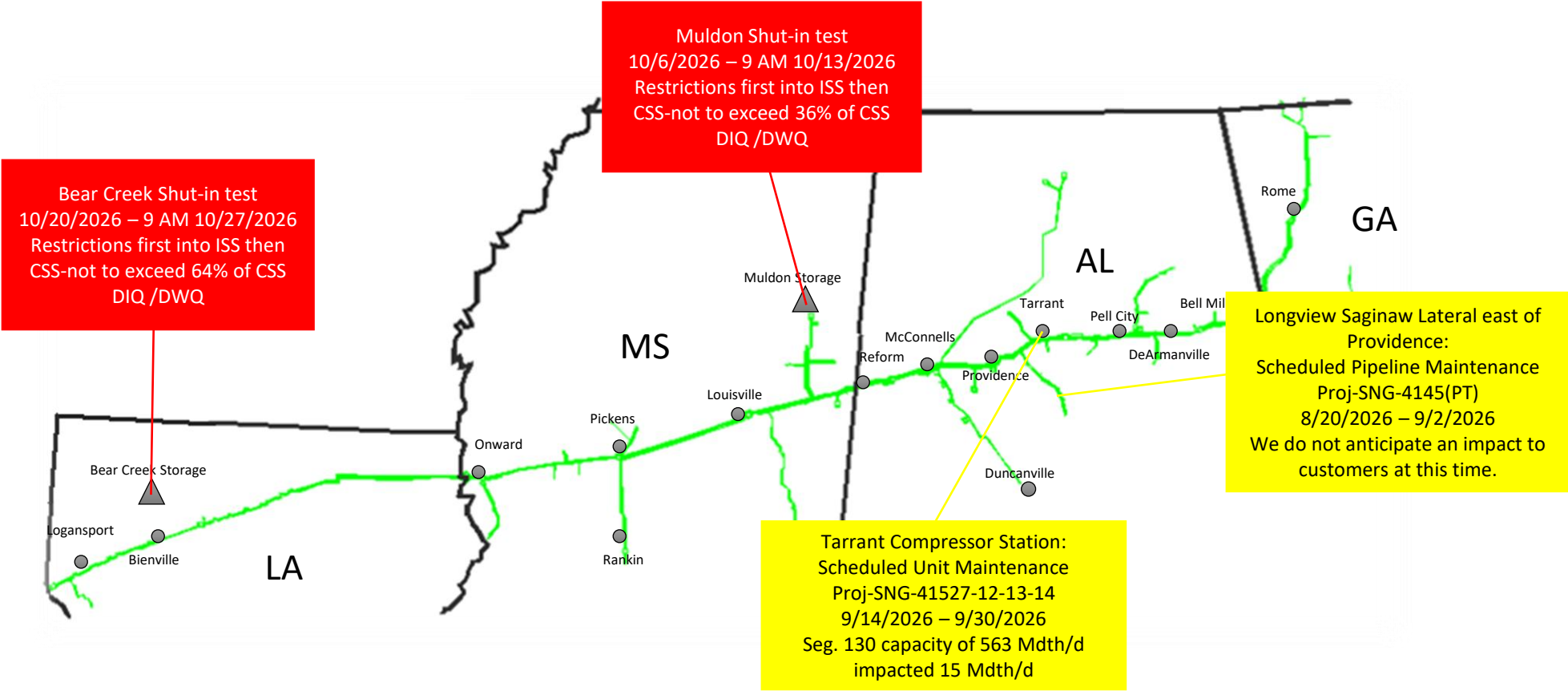
