Enclosed for filing is the annual report reflecting the any Operational Purchases and Sales of gas (“Operational Transactions”) of Bear Creek Storage Company, L.L.C. (“Bear Creek”) made pursuant to Section 18 of the General Terms and Conditions (“GT&C”) of Bear Creek’s FERC Gas Tariff (“Tariff”) for the twelve-month period ending January 31, 2025.

Nature, Basis, and Reasons for Proposed Tariff Changes

Section 18 of the GT&C the Tariff provides that Bear Creek will make an annual filing on or before March 31st of each year indicating the source of any Operational Transactions, the date of the transactions, the quantities, the purchase or sale price, the costs and revenues from the Operational Transactions, the disposition of the associated costs and revenues, and an explanation of the purpose of the Operational Transactions. The attached Appendix A provides this information.
