This filing is the annual report reflecting the Operational Transactions of Bear Creek Storage Company, L.L.C. (“Bear Creek”) made pursuant to Section 18 of the General Terms and Conditions (“GT&C”) of Bear Creek’s FERC Gas Tariff for the twelve-month period ending January 31, 2021.

Section 18 of the GT&C of Bear Creek’s Tariff provides that Bear Creek will make an annual filing on or before March 31st of each year indicating the source of the Operational Transactions, the date of the transactions, the volumes, the purchase or sale price, the costs and revenues from the Operational Transactions, the disposition of the associated costs and revenues and an explanation of the purpose of the Operational Transactions.

Please note that Bear Creek did not have any operational purchases or sales of gas during the calendar year ended January 31, 2021. Therefore, Bear Creek has no operational purchases and sales to report to the Federal Energy Regulatory Commission (“Commission”) for this period.
