Dear Ms. Bose:

Pursuant to Section 4 of the Natural Gas Act ("NGA") and Part 154 of the regulations of the Federal Energy Regulatory Commission ("Commission" or "FERC"), Southern Natural Gas Company, L.L.C. ("Southern") hereby submits for filing and acceptance the following tariff record to its FERC Gas Tariff, Eighth Revised Volume No. 1 ("Tariff") listed below.

Section 2.7 – Statement of Rates – Negotiated Rates Version 19.0.0

Southern requests that the Commission accepts and approves the attached tariff record and corresponding negotiated rate arrangements to be effective November 1, 2018.

Statement of Nature, Reasons and Basis for the Filing

On February 3, 2017 Southern filed an application pursuant to sections 7(c) of the Natural Gas Act (NGA) and Part 157 of the Commission's regulations seeking authorization to construct the Fairburn Expansion Project ("Project") in order to provide additional firm transportation capacity on Southern's existing pipeline system (Docket No. CP17-46). Subsequent to Southern receiving approval for the Project and prior to commencing construction, Southern entered into contracts with various customers for firm capacity associated with the Project. Some of these customers have agreed to pay negotiated rates.

On February 15, 2018 the Commission issued a Certificate of Public Convenience and Necessity ("Order") authorizing Southern to construct and operate the Project, subject to certain conditions. Regarding the negotiated rate agreements associated with the Project, one of the conditions in the Order directed Southern to file either the negotiated rate agreements or tariff records setting forth the essential elements of the agreements not less than 30 days and not more than 60 days prior to the date the project goes into service.

This filing is submitted pursuant to the Commission's Negotiated Rate Policy Statement issued January 31, 1996 in Docket No. RM95-6-000 ("Policy Statement")¹. In the Policy Statement, the Commission announced that it would allow companies to implement negotiated/recourse rate programs.² Section 34 of the General Terms and Conditions of Southern's currently effective tariff allows Southern to charge negotiated rates.

As part of the order granting Southern the authority to negotiate rates for its services, the Commission directed Southern to file either the negotiated rate agreements themselves or a summary of the negotiated rate agreements reflecting the essential elements of such agreements as a tariff record. In this filing, Southern has elected to submit a summary reflecting the essential elements of the new negotiated rate agreements associated with the Project in Section 2.7 of its tariff rather than filing the negotiated rate agreements themselves. The negotiated rate summaries proposed herein reflects the essential elements of the negotiated rate agreements which conform in all material respects with Southern's *pro forma* service agreement in its Tariff.

Southern asks the Commission to accept this tariff filing and permit the proposed tariff record to become effective November 1, 2018, the expected in-service date for the Project.

Pursuant to the applicable provisions of Section 154.7 of the Commission's Regulations, Southern submits the following materials in connection with the filing:
