Pursuant to Section 4 of the Natural Gas Act ("NGA") and Parts 154 and 157 of the regulations of the Federal Energy Regulatory Commission ("Commission" or "FERC"), Southern Natural Gas Company, L.L.C. ("Southern") hereby submits for filing the attached Notification of In-Service requested in FERC's Letter Order dated October 24, 2018 in RP19-18-000 ("Letter Order").

Statement of Nature, Reasons and Basis for the Filing

In compliance with Ordering Condition (B)(2) of the Commission's February 15, 2018 Order granting Section 7 authorizations to Southern in CP17-46-000, Southern provided the Commission with its Notification of In-Service dated December 18, 2018 (the "Notification"). In the Notification Southern notified the Commission that it placed the facilities in service on December 17, 2018. In the Letter Order Southern was directed to file the attached Notification of In-Service with the Commission as an informational filing through the eTariff portal using a Type of Filing Code 620.

Dear Ms. Bose:

On February 15, 2018 the Federal Energy Regulatory Commission (“Commission”) issued in the captioned proceeding, its Order Granting Authorization Under Section 7 of the Natural Gas Act (“February 15 Order”), in which the Commission granted authorization to Southern Natural Gas Company, L.L.C. (“SNG”) to construct and operate the Fairburn Expansion Project consisting of (a) two new pipeline segments, a new compressor station, and three new meter stations, (b) acquisition of an existing pipeline lateral, and (c) modification of two existing meter stations in Fayette, Fulton, Cobb, Clayton and Monroe counties, Georgia (collectively the “Project”). On February 16, 2018, SNG filed to accept the certificate granted by the February 15 Order.

On November 26, 2018 and supplemented on December 12, 2018, SNG requested to place the Fairburn Lateral in Fayette and Fulton Counties, Georgia, the Fairburn Compressor Station in Fulton County, Georgia, the Transco to Southern Meter Station in Fayette County, Georgia and the Jonesboro Meter Station in Clayton County, Georgia into service. The Commission granted SNG’s request by letter order dated December 12, 2018 and SNG placed the authorized facility in-service. Therefore, SNG hereby provides the following notification:
