Dear Ms. Bose:

Pursuant to Section 4 of the Natural Gas Act ("NGA"), Part 154 of the regulations of the Federal Energy Regulatory Commission ("Commission" or "FERC") and in compliance with the Commission's Final Rule in Docket No. RM96-1-042 ("Order No. 587-Z" or "Final Rule"),¹ Southern Natural Gas Company, L.L.C. ("SNG") submits for filing the following tariff record for inclusion in its FERC Gas Tariff, Eighth Revised Volume No. 1 ("Tariff"):

Section 40 NAESB Standards Version 8.0.0

Proposed to become effective June 1, 2022, this tariff record reflects the latest version (i.e. Version 3.2) of the business practice standards adopted by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB").

Background

On July 15, 2021, the Commission issued Order No. 587-Z in the above referenced proceeding to incorporate by reference into its regulations Version 3.2 of the business practice standards developed by the WGQ of the NAESB.² The revisions made by NAESB in Order No. 587-Z are designed to enhance the natural gas industries system and software security measures and to clarify the processing of certain business transactions.

Some of the security measures being updated include (1) implementation of fixes or patches for known vulnerabilities as soon as reasonably practicable with other trading partners; (2) specify notification timelines to provide notice to trading partners of any systems or software that have been updated and the potential impact of using the vulnerable system; and (3) include both

specific and broad adoptions of system security measures and specific notification and coordination during outages with affected partners. Some of the business process being clarified include: (1) updating the nominations related standards to allow a service requester to determine which rights of the contract its segmentation nomination is using; and (2) updating the Quadrant Electronic Delivery Mechanism related standards to define a NAESB standard time frame for information to be retained on a pipeline informational postings website.

Each interstate natural gas pipeline is required to file a compliance filing reflecting the changed standards by November 12, 2021, and to be in compliance with the new standards by June 1, 2022.

Statement of Nature, Reasons and Basis for the Filing

SNG is hereby filing a revised tariff record in compliance with the Commission's Order No. 587-Z. Specifically, SNG is revising Section 40 of its General Terms and Conditions ("GT&C") of its Tariff to reflect NAESB Version 3.2.

Request for Extension of Time

There are several Electronic Data Interchange ("EDI") related data set requirements that are not being used by SNG's customers. These EDI related data sets pertain to the following standards: 0.4.1, 2.4.1, 2.4.2, 2.4.3, 2.4.4, 3.4.1, 3.4.2, 3.4.3, and 3.4.4. SNG is in compliance with these data sets except for the EDI aspect. SNG has not received a request from any party to receive information via EDI pursuant to these data sets. Therefore, SNG respectfully requests an extension of time for compliance until sixty days after SNG receives a request to comply with these listed EDI data set standards. This sixty day period will allow time for SNG to test and implement any of the above listed EDI data sets. This request for extension of time is consistent with the guidelines presented in the Final Rule in Docket No. RM96-1-037 (Order No. 587-V).³ As an oversight, SNG has not earlier requested this extension of time on the above listed EDI data set standards.

Request for Waiver

The NAESB Standard 4.3.60, Version 3.2, has the following wording: "A Customer Activities Web Site should require a single logon/password pair for each user section". SNG is in the process of implementing a multi factor authentication, which would require additional identifying information, versus a single logon/password, to logon to its web site to make it more secure. This new feature should be in place before Version 3.2 becomes effective on June 1, 2022. Once this new multi factor authentication feature is in place, SNG's minimum logon requirements will exceed Standard 4.3.60. Therefore, SNG requests a waiver of Standard 4.3.60 as it relates to requiring a single logon/password.⁴

SNG respectfully requests the Commission accept the tendered tariff record for filing and permit it to become effective June 1, 2022, consistent with the Commission's directive in Order No. 587-Z. With respect to any tariff provision the Commission allows to go into effect without change, SNG hereby moves to place the tendered tariff provisions into effect at the end of the suspension period, if any, specified by the Commission.

Additionally, SNG respectfully requests that the Commission grant all necessary waivers to effectuate this filing.
