Pursuant to Section 4 of the Natural Gas Act (“NGA”), Part 154 of the Federal Energy Regulatory Commission’s (“Commission”) procedures, and the Commission’s May 30, 2024 Order in the above referenced proceeding (“May 30 Order”),¹ Southern Natural Gas Company, L.L.C. (“SNG”) hereby respectfully submits for filing and acceptance the revised tariff record listed below to its FERC Gas Tariff, Eighth Revised Volume No. 1.

Statement of Nature, Reasons, and Basis for the Filing

On May 1, 2024, SNG submitted to the Commission its general NGA section 4 rate case in Docket Nos. RP24-744-000 and RP24-744-001 (“Rate Filing”). In its May 30 Order to the Rate Filing, the Commission directed SNG to, among other things, file within 15 days of the May 30 Order a revised version of the Rate Schedule PAL Statement of Rates tariff record that includes the proposed rate decrease, but removes the “Term Rate” service option, to be effective June 1, 2024. SNG, in this instant filing, is complying with this directive from the May 30 Order.

Procedural

In accordance with the applicable provisions of Part 154 of the Commission’s regulations,² SNG is submitting an eTariff XML filing package with a proposed effective date of June 1, 2024, which includes the following:

1. This transmittal letter; and
2. Clean and marked versions of the tariff record in PDF format in Appendix A.
