#### NOTES:

- Transportation Charges are calculated based on zone of receipt to zone of delivery based on the Dth delivered per day, whether forward haul or backhaul. Deliveries to the Storage PIN are deemed a Zone 0 delivery and receipts from the Storage PIN are deemed a Zone 1 receipt.
- Small Shipper Charges for FT or FTNN service are volumetric charges billed on each Dth delivered based on the zone of the Delivery PIN (in lieu of a monthly Reservation Charge and daily Transportation Charge). The Small Shipper Charge is not assessed on deliveries to the Storage PIN. The ACA surcharge, SCRM surcharge, and fuel apply.
- ACA surcharge is billed for each Dth delivered per day on an FT, FTNN or IT agreement, except it is not charged on deliveries to the Storage PIN or Pool PINs. ACA is revised annually to be effective October 1.
- 4. SCRM surcharge is billed (or credited if a negative surcharge) for each Dth delivered per day on an FT, FTNN or IT agreement, except it is not charged on deliveries to the Storage PIN or Pool PINs. For Supply Pool Balancing Agreements and FTP agreements, the SCRM surcharge is billed on receipts, except it is not charged on receipts from the Storage PIN or Pool PINs. SCRM is filed annually to be effective January 1.
- 5. Fuel is retained on transportation to storage at Zone 0 fuel, and on transportation from storage based on the zone of delivery fuel rate minus the zone 0 fuel rate, but not less than 0%. Transportation fuel is filed semi-annually to be effective April 1 and October 1.
- Storage fuel is collected on net Dth withdrawn and injected each day. Storage fuel is filed annually to be effective April 1.
