




# New Copy Batch Feature

- Enhancement to allow copy of a "Nominated" batch into a new draft
- Shortcut to modify a nomination that is already submitted
- Most useful tool for making changes to a recently submitted nom (ex: volume or party change)

### New Nomination Feature – Copy Batch



-In DART, Go to Nominations folder -Select 'Submitted' to retrieve screen with list of nomination batches in 'Nominated' status -Select nomination batch row

Select "Copy Batch" and enter desired nomination date and cycle to create duplicate batch in draft status. This new draft will include all original nomination inputs of locations, transaction types, volumes, etc.

Once an existing batch is copied, a nomination may be easily modified to resubmit for same date cycle or to build for a future cycle.

### New Conf Sub Cycle Feature

- NAESB feature allowing confirming parties to set volumes for consecutive cycles in the gas day
- Gives confirming parties flexibility to pick and choose which NAESB cycles to set volumes
