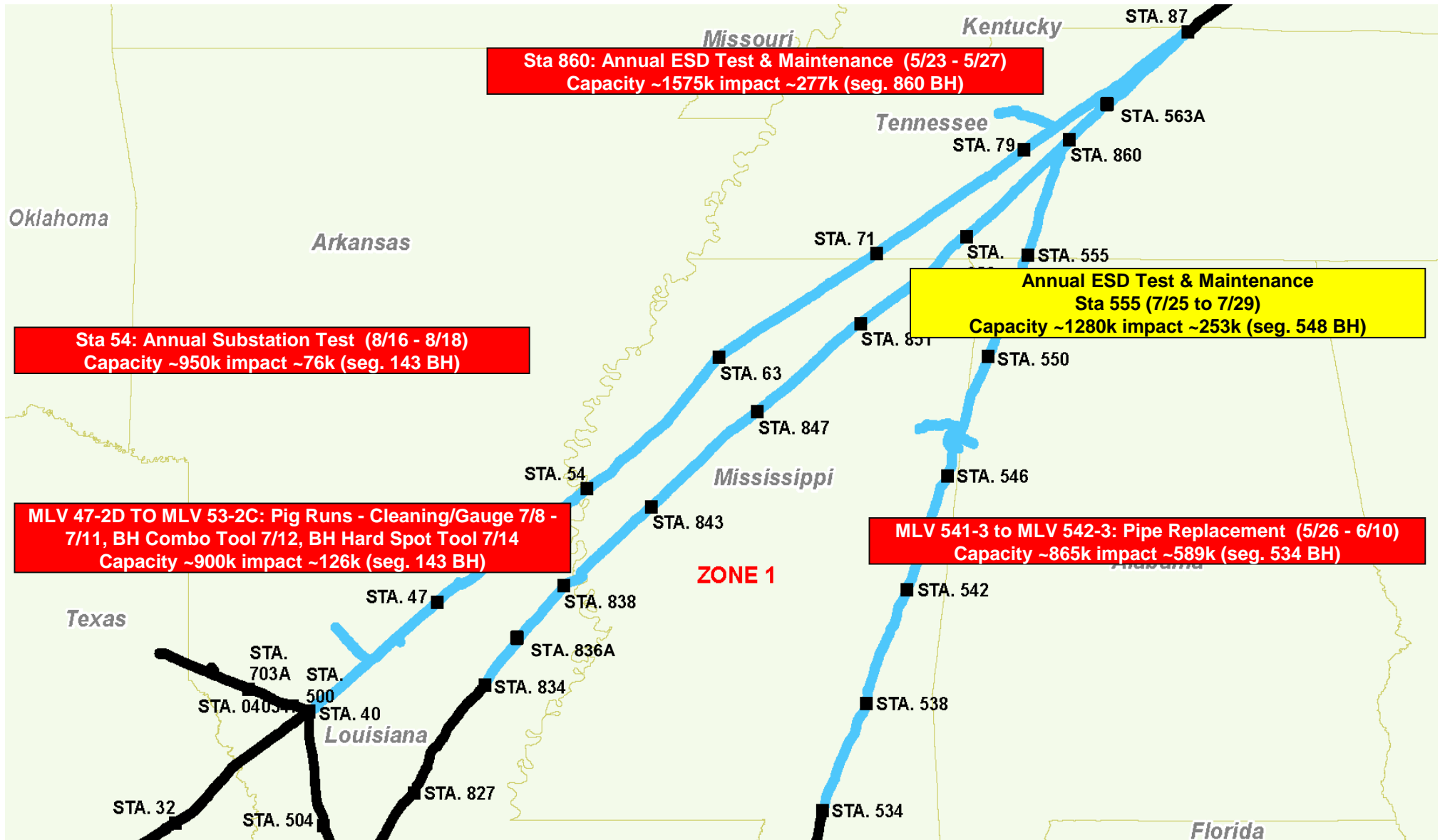
Zone 0 (May - August)



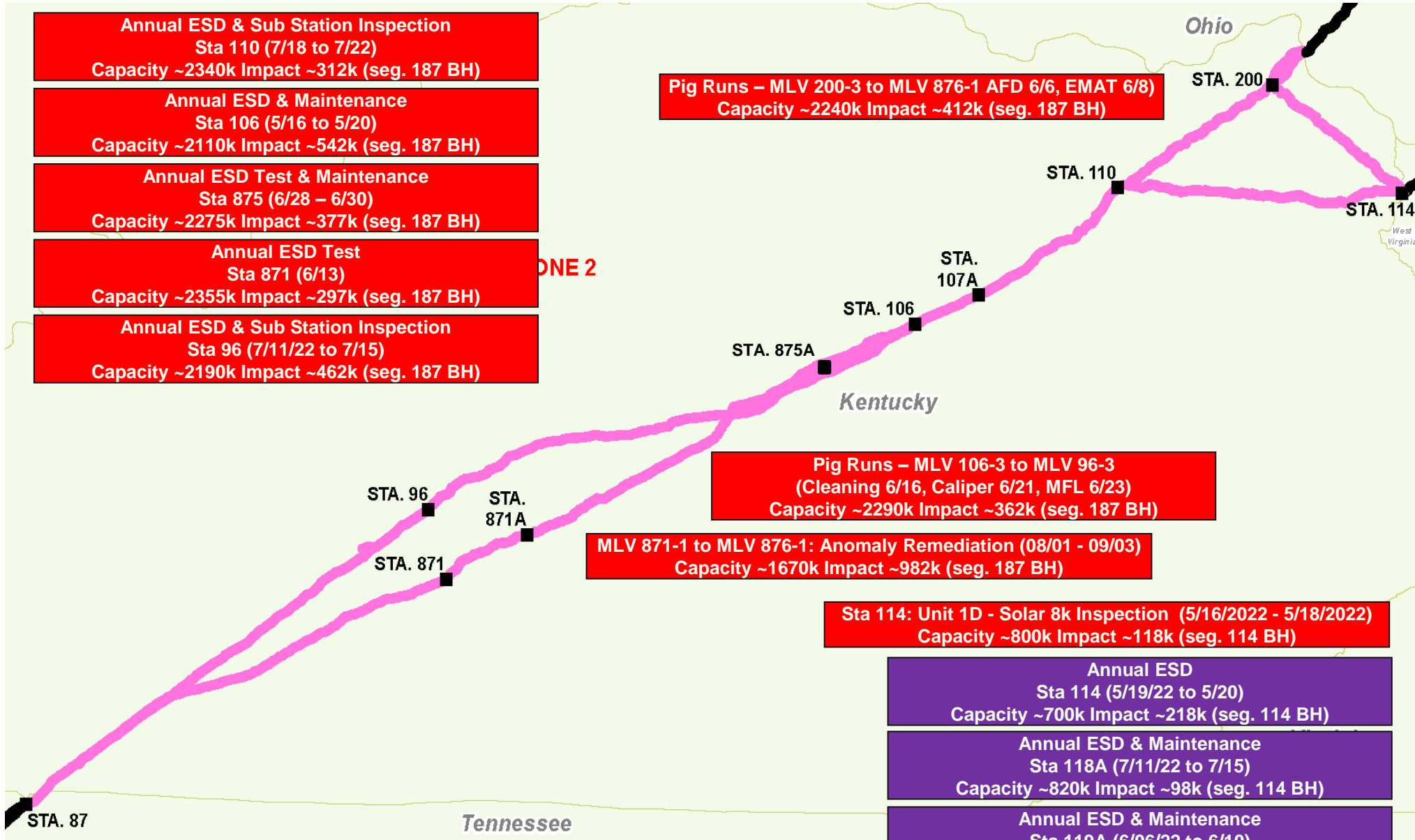
Zone L (May - August)



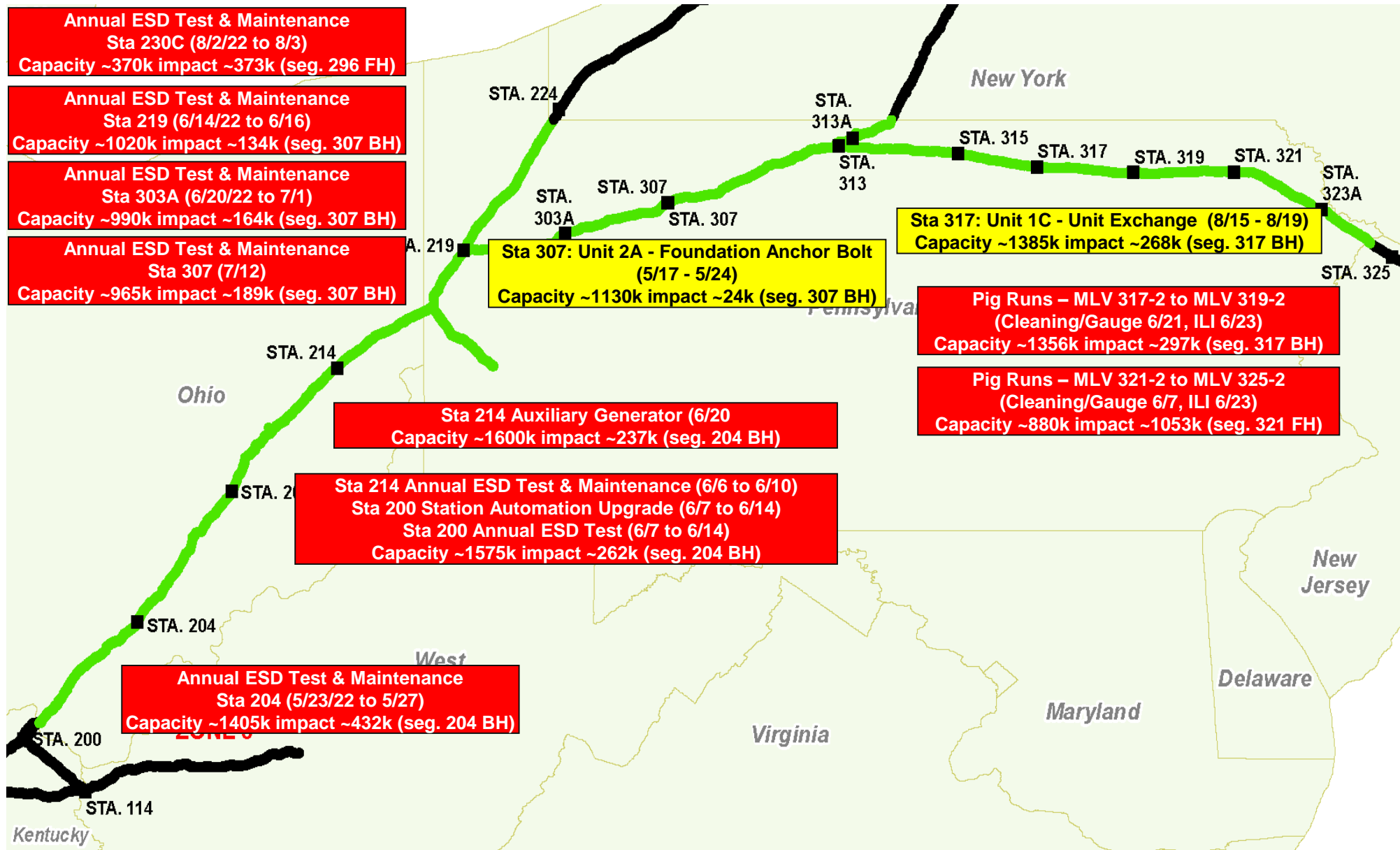
Zone 1 (May - August)



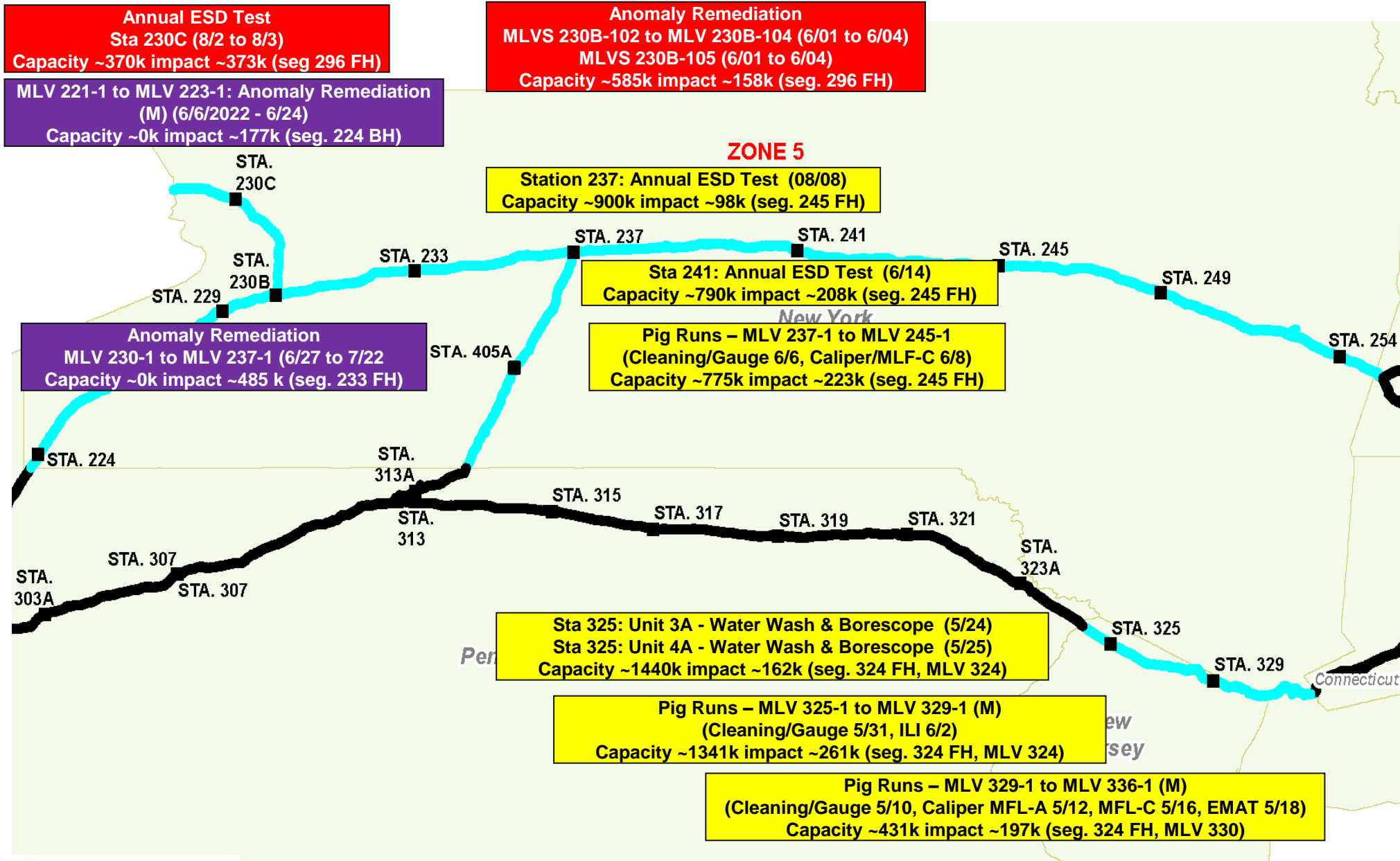
Zone 2 & 3 (May - August)

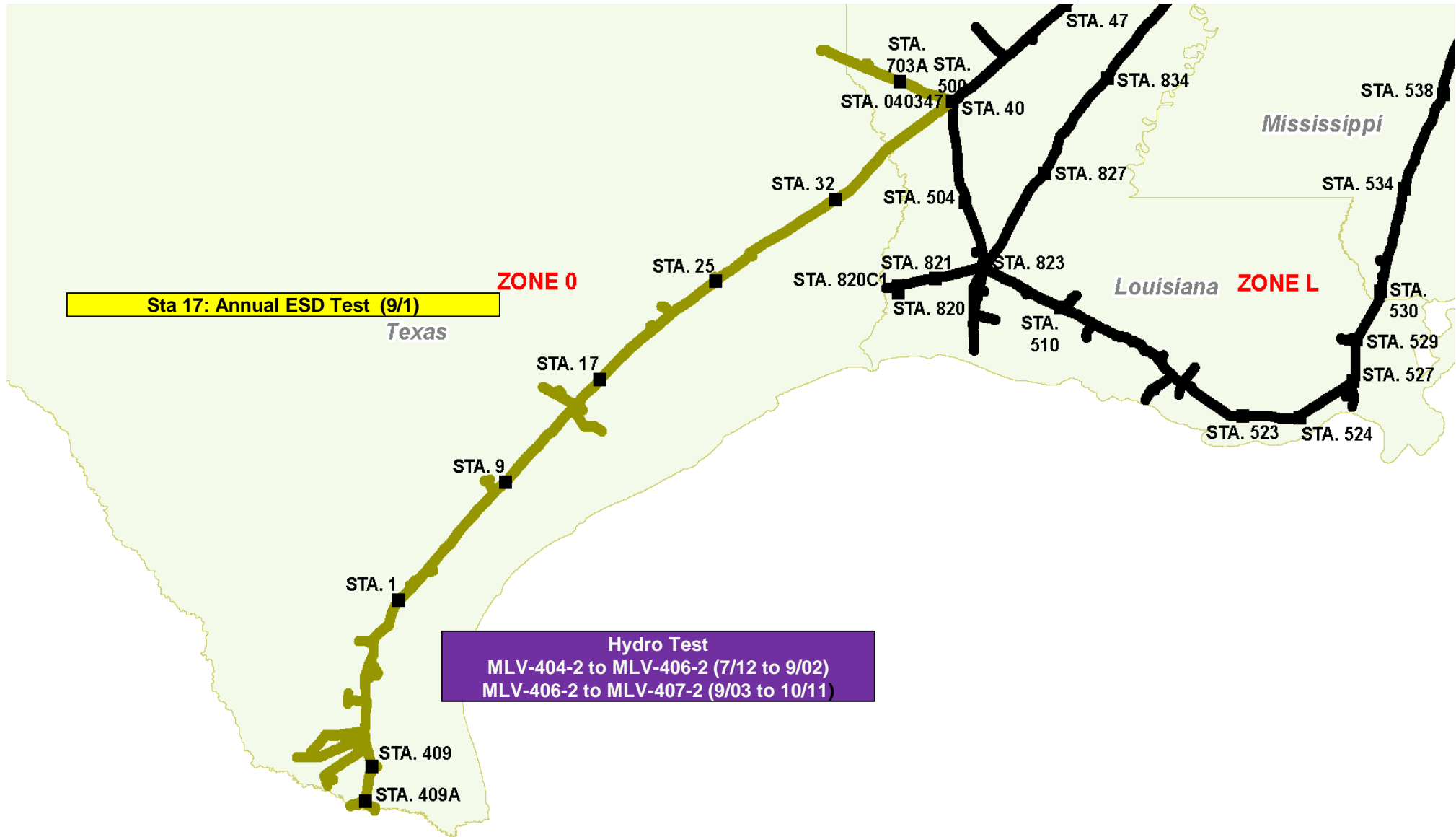

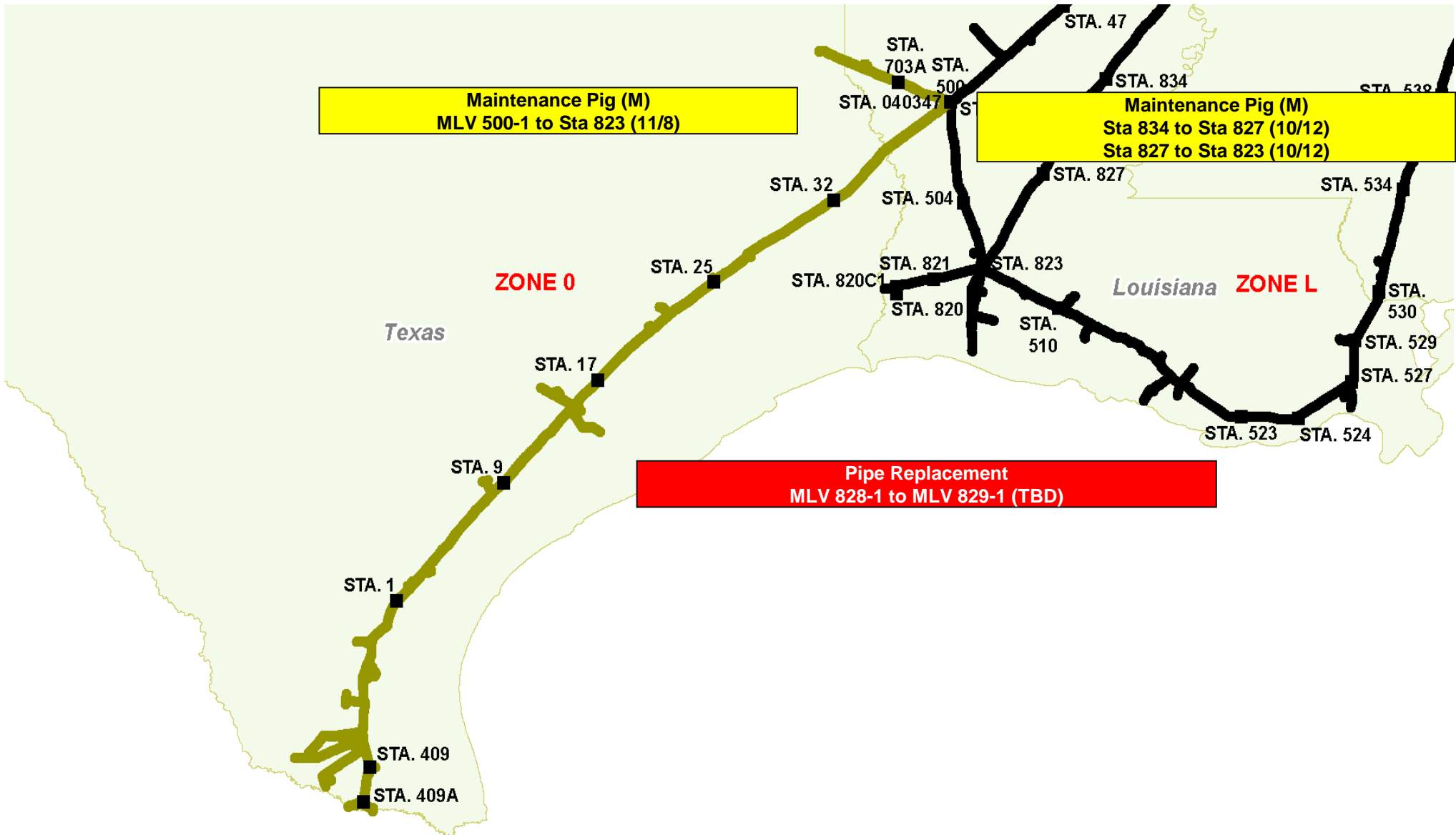

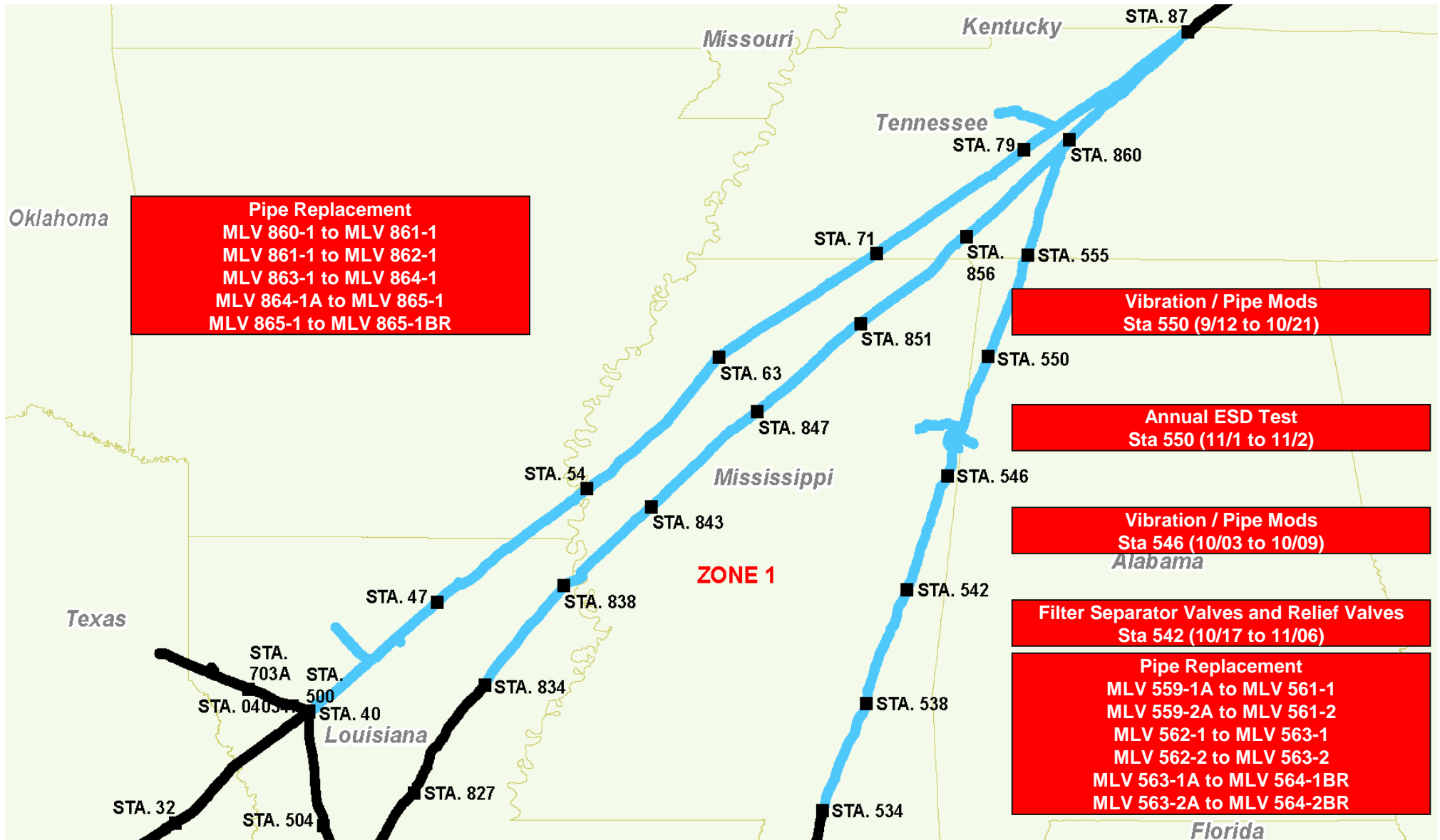
Zone 0 (Future Significant Outages)



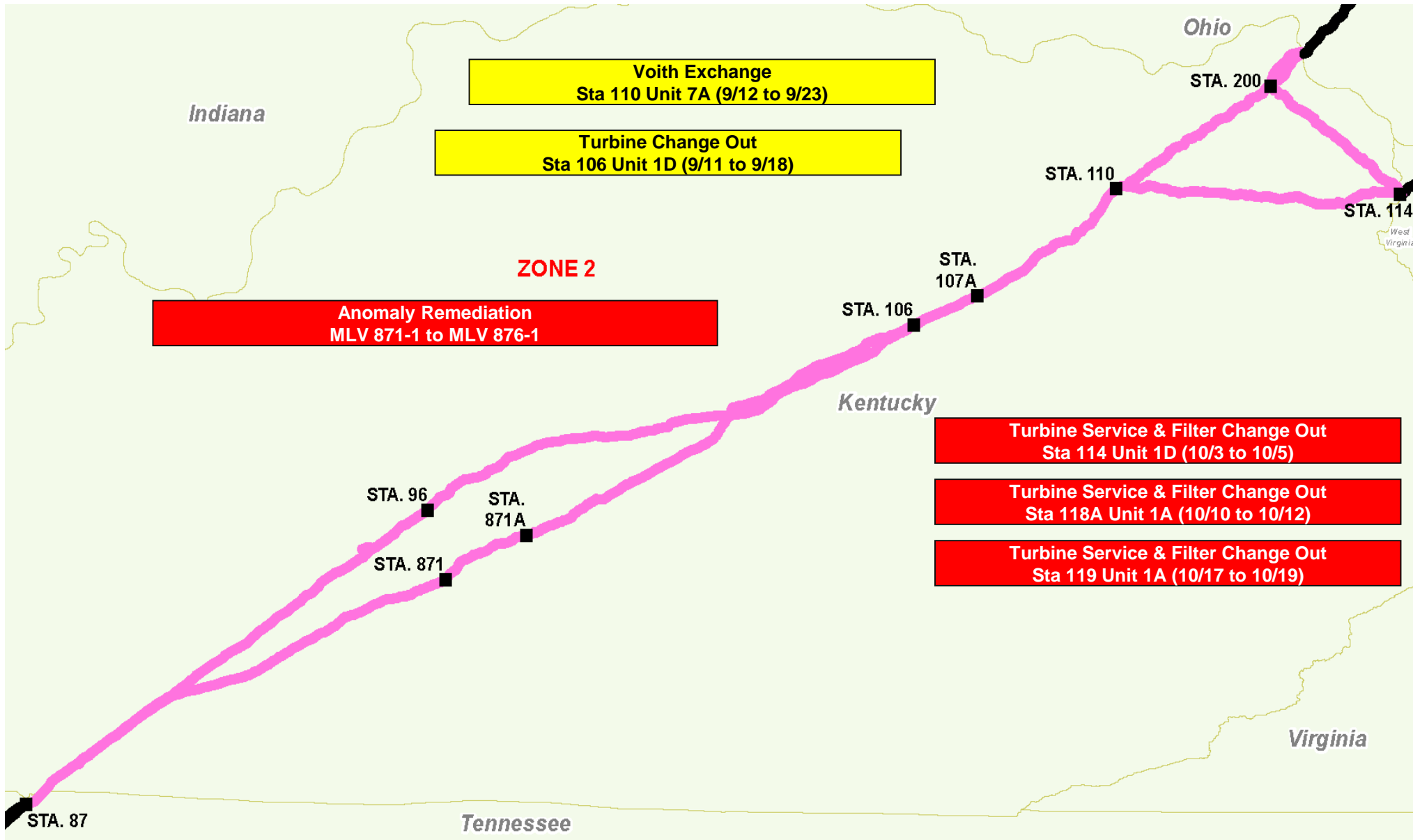
Zone L (Future Significant Outages)



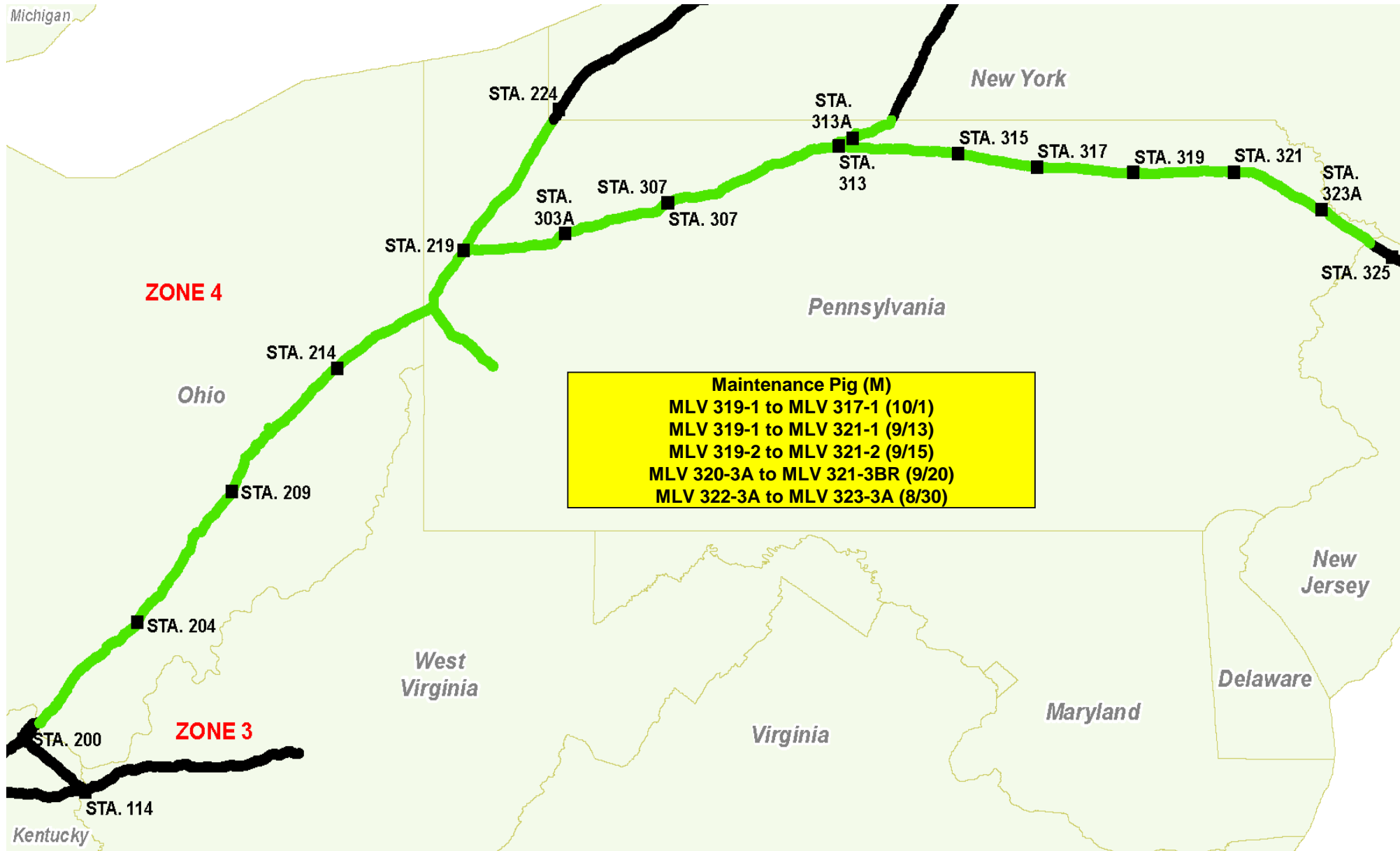
Zone 1 (Future Significant Outages)



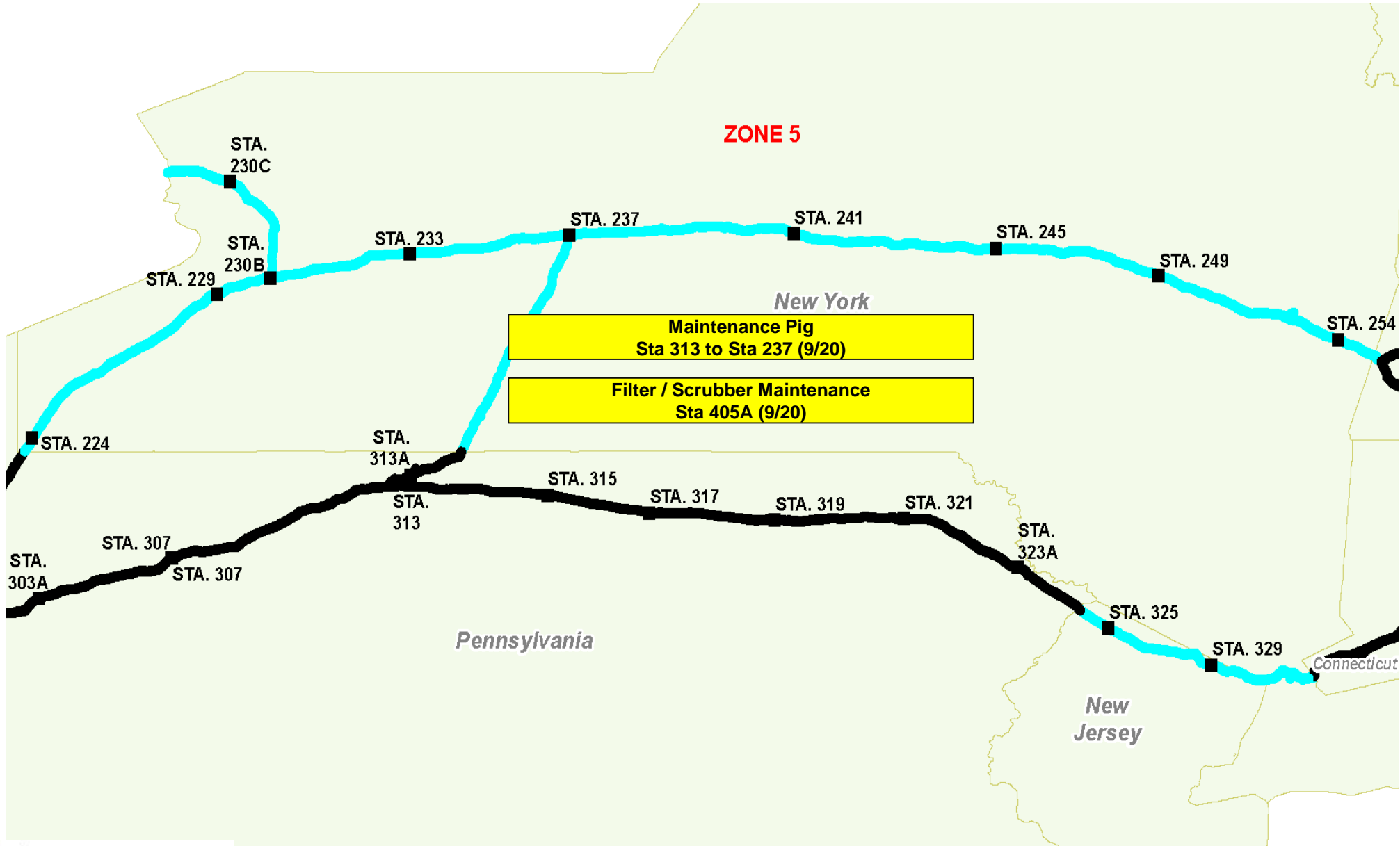
Zone 2 & 3 (Future Significant Outages)



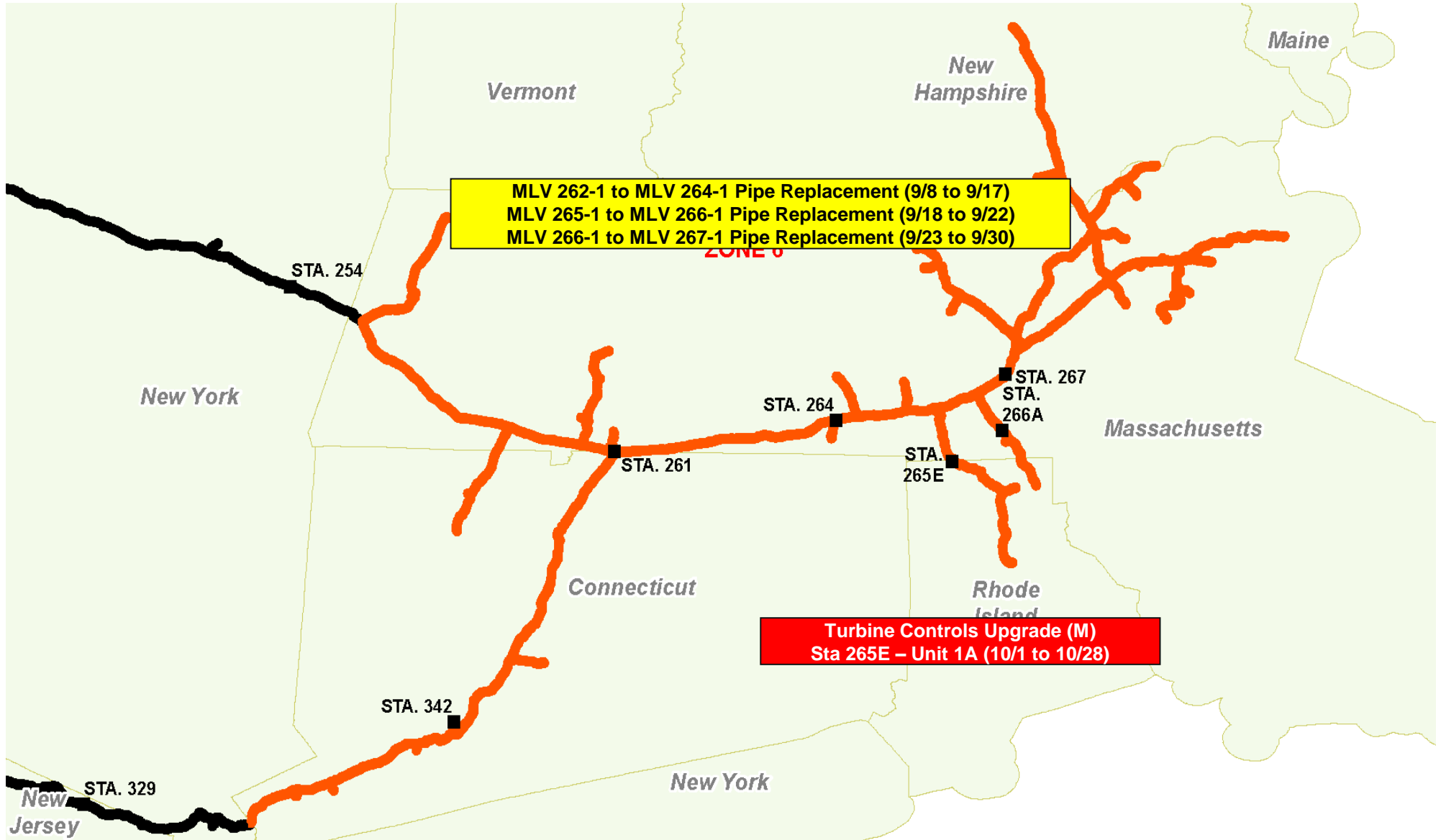
Zone 4 (Future Significant Outages)

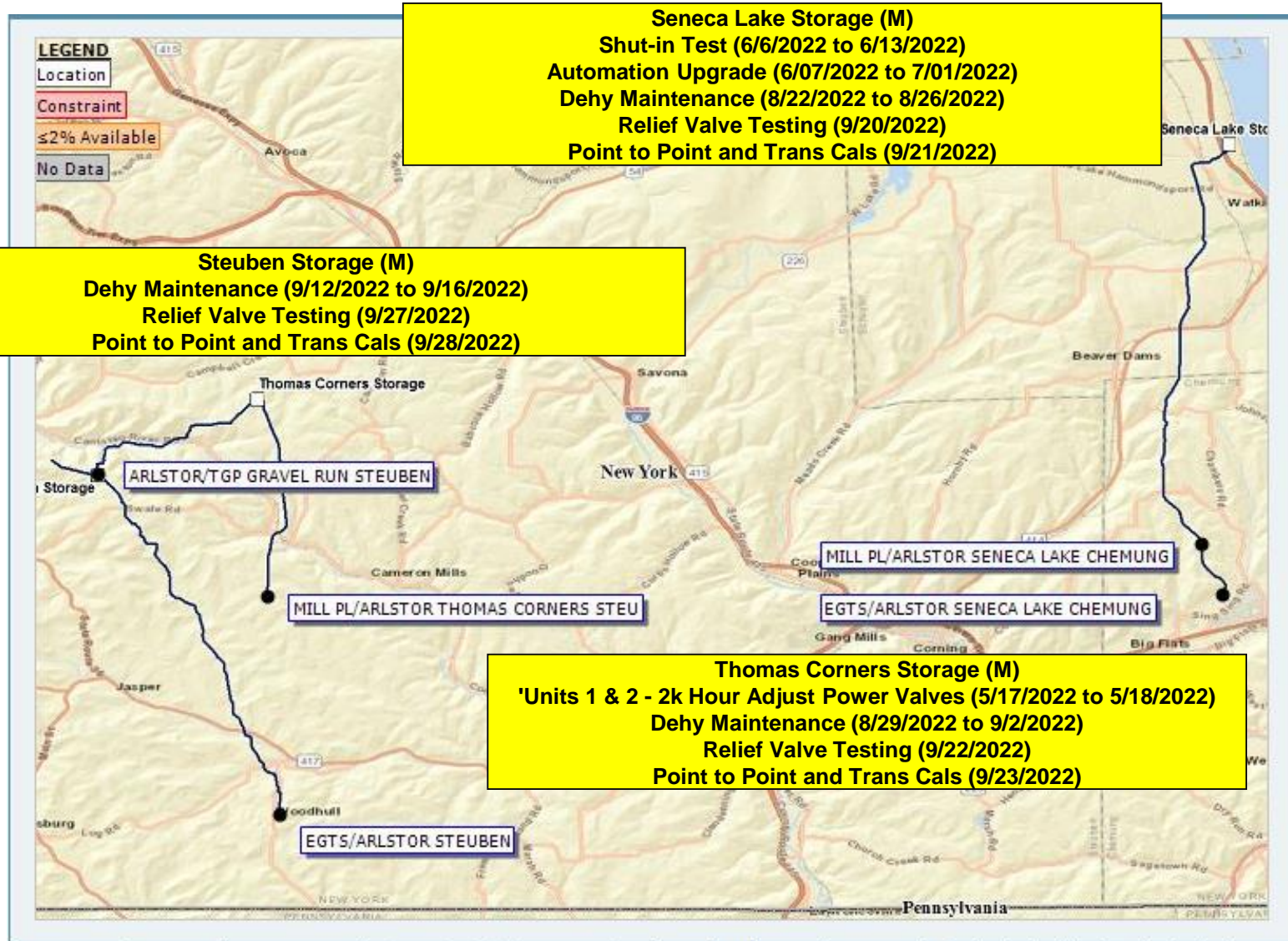

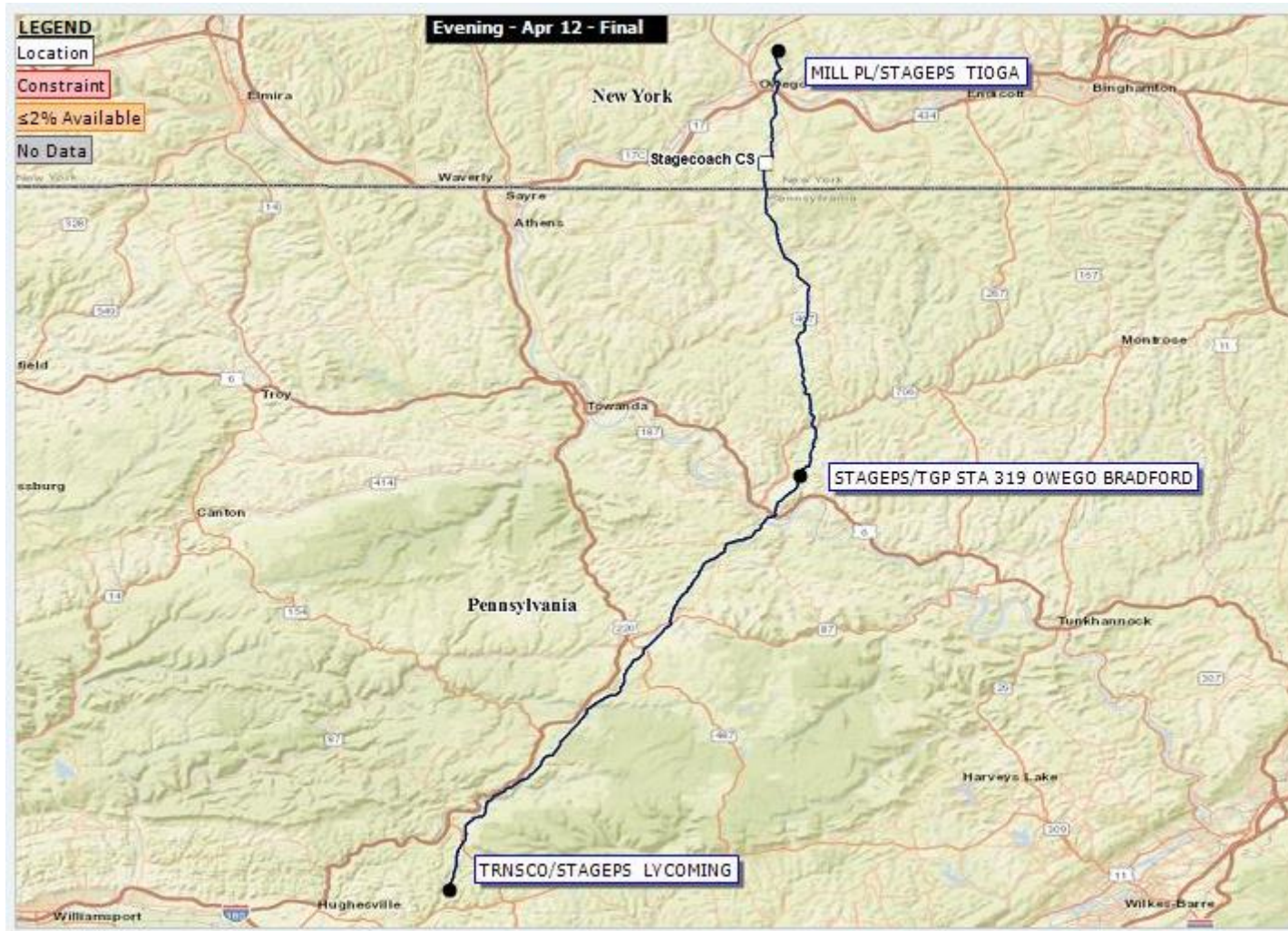

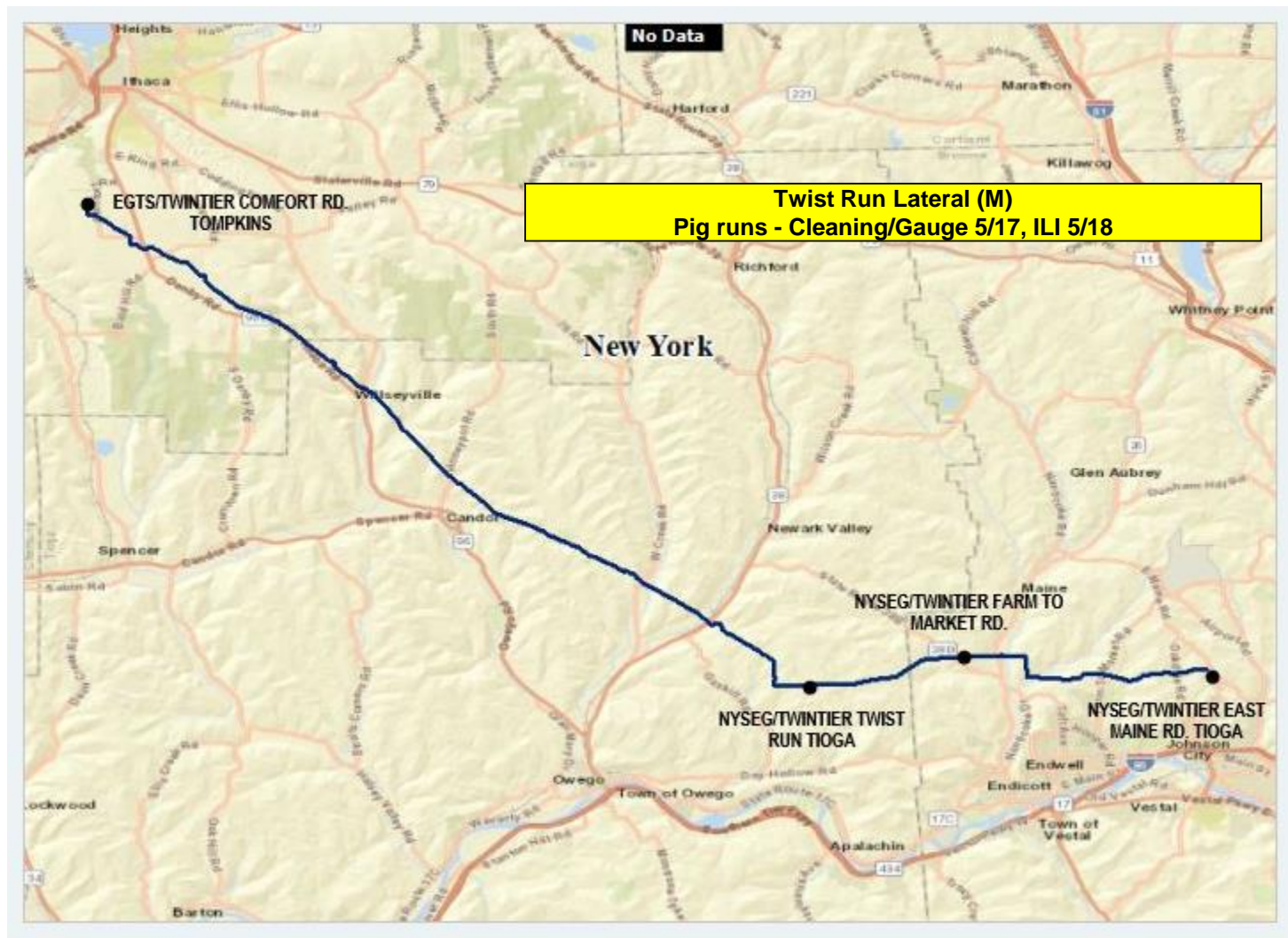
