Dear Ms. Bose:

Pursuant to Section 4 of the Natural Gas Act ("NGA") and Part 154 of the Regulations of the Federal Energy Regulatory Commission ("Commission"), 18 C.F.R. Part 154, Tennessee Gas Pipeline Company, L.L.C. ("Tennessee"), hereby tenders for filing a substitute amended Exhibit A to Service Package No. 100239, between Tennessee and Sequent Energy Management, L.P. ("Sequent") (Service Package No. 100239 shall be referred to herein as the "Sequent Service Agreement").

Tennessee submits the substitute amended Exhibit A for inclusion in Section 2.1.1 of First Revised Volume No. 2 of Tennessee's FERC Gas Tariff ("Tariff"). The proposed Tariff record is listed on Appendix A. Tennessee respectfully requests that the Commission accept and approve the substitute amended Exhibit A and the related Tariff record effective on April 1, 2018.

Statement of Nature, Reasons, and Basis for the Filing

On March 21, 2018, Tennessee submitted for filing and approval in Docket No. RP18-576-000, a Negotiated Rate Agreement dated February 27, 2018 and an Amendment No. 4 to Exhibit A to a Gas Transportation Agreement with Sequent. The amended Exhibit A contained amended delivery and receipt points and associated meter quantities to be effective April 1, 2018. This filing is pending Commission approval. The purpose of the instant filing is to replace the amended Exhibit A filed in Docket No. RP18-576-000 with the amended Exhibit A filed herewith in order to correct certain receipt and delivery point location descriptions shown in Exhibit A which were caused by a computer system glitch.

Tennessee is including herewith a marked copy of Exhibit A showing the amended primary receipt/delivery points and associated meter quantities under the Sequent Service Agreement. Other than the corrections to the primary receipt and delivery point location

descriptions shown in Exhibit A attached hereto, all other substantive terms of the Sequent Service Agreement are the same as the agreement previously filed in this docket.
