Commissioners:

Wyoming Interstate Company, L.L.C. ("WIC") is hereby filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP23-14-000, notification of abandonment activities and an affirmative statement associated with the Diamond Mountain Abandonment Project.

Description of Proceeding

On November 10, 2022, WIC filed an application pursuant to Section 7(b) of the Natural Gas Act, and Part 157.5, et seq., of the Commission's Regulations, for authorization to abandon, in place, its Diamond Mountain Compressor Station located at approximate Milepost 54.8 on WIC's 24-inch diameter Kanda Lateral in Uintah County, Utah. This project is referred to as the "Diamond Mountain Abandonment Project". On June 12, 2023, the Commission issued WIC its Order Approving Abandonment ("Order") in Docket No. CP23-14-000.¹

Affirmative Statement and Notification of Abandonment

In compliance with ordering paragraph (A) of the Commission's Order, WIC is herein informing the Commission that all abandonment activities associated with the Diamond Mountain Abandonment Project were completed on September 13, 2023.² Furthermore, in compliance with Environmental Condition No. 7 of the Appendix to the Order, WIC herewith files with the Secretary of the Commission, an affirmative statement that the facilities associated with the Diamond Mountain Abandonment Project have been abandoned in compliance with all applicable conditions.

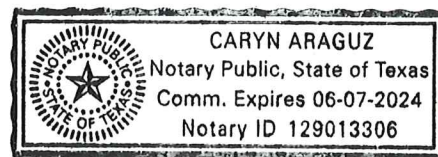
