Commissioners:

In compliance with the Federal Energy Regulatory Commission's ("Commission") Final Rule in Docket No. RM96-1-044, ("Order No. 587-AB" or "Final Rule"),¹ Wyoming Interstate Company, L.L.C. ("WIC") submits for filing the following tariff record for inclusion in Part IV of its FERC Gas Tariff, Third Revised Volume No. 2 ("Tariff"):

Section 22 Compliance with 18 CFR, Section 284.12 Version 10.0.0

Proposed to become effective January 1, 2027, to comply with Order No. 587-AB, this tariff record reflects the latest revisions to certain Version 4.0 business practice standards adopted by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB") as adopted by the Commission in Order No. 587-AB.

Reason for Filing

On May 22, 2026, the Commission issued Order No. 587-AB amending its regulations to incorporate by reference, with certain exceptions, revisions to Version 4.0.² As described in the Final Rule,³ the revisions to Version 4.0 standards include: 1) a new standard addressing the posting of scheduled quantity information for power plants directly connected to a pipeline, 2) an update to an existing electronic delivery mechanism standard to establish a new information posting category on a pipeline's informational postings web site, and 3) a new

standard that addresses the inclusion of geographical information in critical notices.

In Order No. 587-AB, the Commission noted that it would continue the compliance filing requirements first established in Order No. 587-V.⁴ Accordingly, for each standard, Order No. 587-AB requires the pipeline to specify in the tariff section listing all the NAESB standards: a) whether the standard is incorporated by reference; b) for those standards not incorporated by reference, the tariff provision that complies with the standard; or c) for those standards with which the pipeline does not comply, an explanatory statement, including an indication of whether the pipeline has been granted a waiver, extension of time, or other variance with respect to compliance with the standard.⁵ With the Final Rule and consistent with Order No. 587-V, the Commission also mandated that pipelines request to continue any existing waivers or extensions, as necessary.⁶ The Final Rule requires each interstate natural gas pipeline to submit a compliance filing reflecting the changed standards by September 1, 2026, to take effect on January 1, 2027.⁷

Description of Filing

WIC is hereby filing an updated tariff record in compliance with the Commission's Order No. 587-AB. Specifically, WIC is revising Section 22 of its General Terms and Conditions to incorporate the NAESB WGQ standards adopted by reference in the Final Rule and to reflect the waivers, extensions of time, and variances requested below.

Incorporation of NAESB Version 4.0

Part IV, Section 22 is updated to reflect the addition of and modification to three NAESB WGQ standards in the Version 4.0 revision, the applicable copyright years, and the inclusion of a citation to the relevant Commission order(s) on previously accepted variances, waivers, and extensions. Additionally, this tariff record reflects a housekeeping update to remove a certain standard (i.e., 12.2.20), given that such standard is no longer included in the Cybersecurity Related Standards definitions.

Continuance of Variance

In Part IV, Section 6, WIC's Tariff includes a variance to NAESB WGQ Standard 1.3.2, which extends the nomination periods for an additional fifteen

minutes.⁸ The additional fifteen minutes conforms to Commission policy that pipelines may modify NAESB standards to provide better service to its customers.⁹ This variance was accepted by the Commission in previous orders.¹⁰

Continuance of Extension

WIC's Tariff includes an extension of time to comply with NAESB WGQ Standards for certain data sets for Electronic Data Interchange ("EDI") related requirements. Though WIC supports some of these data sets, there are several that have never been requested by any party to receive information by EDI pursuant to the data sets found in NAESB Standards: 0.4.1, 2.4.1 through 2.4.2, and 3.4.2 through 3.4.4. Therefore, WIC respectfully requests a limited extension of time until 60 days after the receipt of a request by a Part 284 shipper to use such a standard and dataset for WIC to comply with these EDI data set standards. This 60-day period will allow time for WIC to test and implement any of the above listed EDI data sets if and when a shipper requests to use such an EDI data set. WIC's original request for extension on these standards was accepted by the Commission in its *Order On Filings In Compliance With Order No. 587-Z*.¹¹ WIC is not seeking a continuation of its existing NAESB Standards 2.4.3 and 2.4.5 extension because it is no longer necessary.

Table for Request to Continue Waivers, Variances or Extensions

As required by Order No. 587-AB for requests for a continuation of a waiver, variance, or extension,¹² WIC is providing the table below identifying the standard for which a variance, waiver, or extension of time was granted, and the docket number or order citation to the proceeding wherein the waiver, variance, or extension was granted.
