Wyoming Interstate Company, L.L.C. ("WIC") is hereby filing with the Federal Energy Regulatory Commission ("Commission") in Docket No. CP18-117-000, its weekly status report related to the Cheyenne Compressor Station Expansion Project ("Project").

Description of Proceeding

On March 15, 2018, WIC filed a prior notice request pursuant to Sections 157.205, 157.208(b), and 157.210 of the Commission's regulations under the Natural Gas Act for authorization to reclassify one compressor unit that currently serves as a spare unit to mainline service and increase the available horsepower at its existing WIC Cheyenne Compressor Station located in Weld County, Colorado. The project is referred to as the "WIC Cheyenne Compressor Station Expansion Project." On March 23, 2018, the Commission issued a Notice of Request Under Blanket Authorization initiating the 60 day comment period to allow for any person or Commission's staff to file motions or notice to intervene and protests. Since no protests were filed within the comment period, the Project was deemed to be authorized on May 23, 2018.

Submittal of Status Report

In compliance with Section 157.208(c)(10) of the Natural Gas Act, WIC is providing Environmental Inspector Report No. 17 for the period of October 14, 2018 through October 20, 2018.

Filing Information

WIC is e-Filing this letter and report with the Commission's Secretary in accordance with the Commission's Order No. 703, *Filing Via the Internet*, guidelines issued on November 15, 2007 in Docket No. RM07-16-000.

Construction Status: During this reporting period, WIC conducted hydrostatic testing on the Sparrow Meter Station and tap assembly facilities. In addition, crews continued slot trenching activities for the plant yard piping and fabrication work at the scrubber vessel site.

Grading: There were no grading activities during this reporting period.

Erosion Control: Erosion controls were inspected and are performing as expected.

Work Planned for the Following Reporting Period (10/21/18 - 10/27/18): During the next reporting period, instrumentation will be installed at the Sparrow Meter Station and Flying Hawk Meter Station and flow control spools will be installed at just the Flying Hawk Meter Station. In addition, crews will begin work on installing the plant yard piping at the interconnection with the Sparrow Meter Station.

Correspondence from Federal, State, and Local Agencies Concerning Compliance Issues: No federal, state or local permitting agency has notified WIC of instances of noncompliance.

Landowner Complaints: There were no landowner/resident complaints received during the reporting period.

Environmental Training: During this reporting period, environmental training was provided to 28 people. To date a total of 228 employees have received environmental training.
